### What is this product?

#### Type

The product is a share class of FTGF Western Asset US High Yield Fund (the "Fund") which is part of the Franklin Templeton Global Funds plc, an investment company with variable capital incorporated with limited liability in Ireland and established as an umbrella fund with segregated liability between sub-funds.

Term

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

#### **Objectives Investment Objective**

The Fund's investment objective is to provide a high level of current income. Investment Policy

. The Fund will seek to achieve its investment objective by investing at least 70% of its net asset value in high-yielding debt securities and instruments of US issuers (such investment may be directly in such shares or indirectly via investments in other investment funds) that are denominated in US dollars that are listed or traded on regulated markets listed.

• The Fund many invest up to 10% in contingent convertible bonds (bonds that can convert into equity upon a specified event taking place).

•The bonds purchased by the fund may be issued by corporations and governments.

• The Fund may invest in debt securities rated as low as D by S&P or the equivalent by another NRSRO, which ratings indicate that the obligations are highly speculative and may be in default or in danger of default as to principal and interest. The Fund may invest in derivatives, financial instruments whose value is derived from the value of other assets, to help try to achieve the Fund's objective as well as to reduce risk or cost or to generate additional growth or income for the Fund.

What are the risks and what could I get in return?

#### Intended retail Investor

The Fund may appeal to investors looking to receive a high level of income by obtaining exposure to high yield (riskier) debt securities and instruments of US issuers that are denominated in US Dollars as well as derivatives. Investors should be willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.

### Costs over Time
