

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

- **Type:** The product is a Sub-fund of Gamax Funds FCP (the Fund), an open-ended umbrella Unit Trust established by Mediolanum International Funds Limited as a UCITS pursuant to the provisions of the UCITS Regulations and governed by Luxembourg law.
- Term: This is an open ended fund with no maturity date.
- Objectives:
 - The Sub-Fund's objective is to achieve long term capital growth.
 - The Sub-Fund invests in global (including up to 30% in emerging market) equities (listed shares) and equity related securities of companies with long term growth potential and whose products/services are aimed at the younger generation.
 - The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es). Their use may be for efficient portfolio management, hedging and/or direct Investment purposes.
 - The Sub-Fund may enter into securities lending transactions.
 - The Sub-Fund is actively managed (meaning that the Manager has full discretion over the composition of the Sub-Fund's portfolio of assets) and is not managed with reference to any benchmark.
 - The product is compatible with investors that can bear and/or afford to fully or partially lose the capital invested and are comfortable with no capital guarantee.
 - Income and gains generated by the unit class will be reinvested. No dividend will be paid.
 - Units can be bought or sold on any business day from the Transfer and Register Agent.

What are the risks and what could I get in return?



- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
- We have classified this product as 4 out of 7, which is a medium risk class.
- This rates the potential losses from future performance at a medium level, and poor market conditions are very unlikely to impact the capacity of the issuer to pay you.

What happens if Mediolanum International Funds Limited is unable to pay out?

However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. In such a scenario, there is no investor guarantee scheme and you could lose all of your investment.

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and the performance of the product. - In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.
