## What is this product?

### Type

A contractual investment fund of the "other funds for traditional investments" type.

### Term

The investment fund is established for an indefinite period. The Fund Management Company may initiate the dissolution of the investment fund by terminating the fund agreement.

### Objectives

#### Investment Objective

The Fund's investment objective is to achieve long-term capital growth.

#### Investment Policy

The investments are made predominantly in the shares of Swiss companies. In addition to financial considerations, the Fund integrates environmental, social and governance (ESG or sustainability) aspects into every step of the investment process. The following approaches are applied: Standards-based exclusions of JSS, best-in-class, ESG integration and active ownership. More detailed information can be found in the Prospectus.

The Swiss Performance Index (SPI)<sup>®</sup> serves as a benchmark for judging the success of the investments. However, the index does not constrain

the selection of Fund investments. The asset manager has complete discretion in making the investment decisions.

#### Share Class Policy:

This unit class of the Fund distributes income to investors in December as a general rule.

#### Processing of subscription and redemption orders

You can buy and sell units in this Fund on any bank business day in Switzerland.

#### Intended retail Investor

The Fund is suited to investors with a long-term investment horizon seeking capital growth. It is intended for retail investors as a basic investment in Swiss equities. The value of equities is primarily influenced by market and sector-specific factors and may therefore rise as well as fall. Investors can exploit any resulting fluctuations in the net asset value of the fund units and are not tied to a specific date on which to realise the investment.

## What are the risks and what could I get in return?

### Risk Indicator



The risk indicator assumes you keep the product for 7 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the capacity to pay you.

**Be aware of currency risk.** You will receive payments in a different currency, so the final return you will get depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

## What happens if J. Safra Sarasin Investmentfonds AG is unable to pay out?

## What are the costs?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
