# LYXOR EPSILON GLOBAL TREND FUND I-EUR (the "Fund")

ISIN: IE00B643RZ01 - A sub-fund of the investment company named LYXOR INVESTMENT STRATEGIES PLC (the "Company") domiciled in Ireland. Managed by Lyxor Asset Management S.A.S. ("LAM")

## Objectives and investment policy

The Fund seeks to achieve capital appreciation over the medium to long term by implementing the Lyxor Epsilon Global Trend Strategy in investing primarily in futures and options traded on organized exchanges. The Lyxor Epsilon Global Trend Fund investment strategy provides exposure to several asset classes on the global markets (including equities, bonds, interest rates, volatility and currencies), according to a systematic model based investment process. Such systematic model-based process aims at implementing a trend following strategy that seeks to identify upward and downward prices trends and to capitalize on them. Such process relies on quantitative signals (some of which are price momentum and volatility signals), combines medium term and long term approaches and is subject to an ongoing improvement by a dedicated research team.

The share currency is the Euro (EUR).

- Invested financial instruments: Financial Derivatives Instruments (FDI), structured debt securities, fixed income securities and money market instruments, cash deposits and near cash instruments.
- Dividend policy: all the Fund's amounts available for distribution (if any) shall not be distributed to Shareholders, but reinvested.
- Net Asset Value: the Net Asset Value per share is calculated on each Business Day or such other day or days as may be determined by the Directors and notified to Shareholders in advance.
- Redemptions: redemption requests shall be received on any Business Day (D) at or before 12:00 PM Irish Time to be executed on the Net Asset Value of D calculated as of D+1.

## Risk and reward profile



The risk-return category shown above is based on the maximum level of risk that the Fund manager may take while adhering to the Fund's strategy, as well as on its performance, where applicable. The Fund has been classified within category 5. Category 5 indicates that under normal market conditions a significant loss of capital is possible; the value of your investment may change significantly and have above average daily upside or downside variation.

Main risks not covered by the above indicator which could lead to a decrease in the net asset value of the Fund and which the Fund is authorized to disclose in this document (for more details about risks, please refer to the Risk Profile section of the prospectus):

- Counterparty risk: The Fund is exposed the risk that any counterparty with which it has concluded an agreement or a transaction could become insolvent or otherwise default and more particularly when it has concluded financial derivative instruments over-the-counter or securities lending transactions. If such an event occurs, the net asset value of the Fund may decrease significantly. According to the regulation applicable to the Fund, such risk cannot exceed 10% of the Fund's total assets per counterparty.
- Credit risk: The Fund is subject to the risk that any issuer could become insolvent or to otherwise event having an impact on the credit quality of this issuer. The consequence of this risk or event may result in a decrease of the net asset value of the Fund.
- Risk of Financial derivative Instruments: The Fund invests in financial derivative instruments. These financial derivative instruments can induce different type of risks such as (but not limited to), leverage risk, high volatility risk, valuation risk or liquidity risk. If this risk occurs, the net asset value of the Fund may decrease significantly.


