

# Key Investor Information

This document provides you with key investor information about this Fund. It is not marketing material. ### Objective and investment policy

The fund aims to provide:

- a combination of capital growth and income to deliver a return that is higher than that of the US stockmarket over any five-year period, while applying ESG Criteria;
- an income distribution that increases every year in USD terms.

**Core investment:** At least 80% of the fund is invested in the shares of companies, across any sector and of any size, that are based, or do most of their business, in the US and Canada. The fund is concentrated and usually holds shares in fewer than 50 companies.

The fund invests in securities that meet the ESG Criteria. Norms, sector and/or values-based exclusions apply to investments.

**Other investments:** The fund may invest in the shares of non-US and non-Canadian companies, other funds and cash or assets that can be turned into cash quickly.

**Derivatives:** To reduce risks and costs.

Strategy in brief:

- Investment approach: The investment manager focuses on companies with the potential to grow their dividends over the long term and selects stocks with different sources of dividend growth to build a fund that has the potential to cope in a variety of market conditions.
- Responsible investment approach: The fund is categorised as Planet+ / ESG Enhanced, as defined in the fund's prospectus.

**Benchmark:** S&P 500 Net Total Return Index

The benchmark is a comparator against which the fund's performance can be measured. It is a net return index which includes dividends after the deduction of withholding taxes. The index has been chosen as the fund's benchmark as it best reflects the scope of the fund's investment policy. The benchmark is used solely to measure the fund's performance and does not constrain the fund's portfolio construction.

The fund is actively managed. The investment manager has complete freedom in choosing which investments to buy, hold and sell in the fund. The fund's holdings may deviate significantly from the benchmark's constituents.

The benchmark is not an ESG benchmark and is not consistent with the ESG Criteria.

For unhedged and currency hedged share classes, the benchmark is shown in the share class currency.

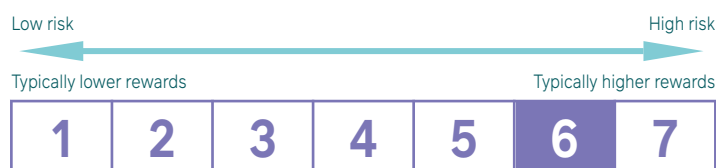
You can buy and sell shares in the fund on any business day. Instructions received before 13:00 Luxembourg time will be dealt at that day's price.

Any income from the fund will be rolled up into the value of your investment.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These may have a material impact on your returns.

Recommendation: This fund may not be appropriate for investors who plan to withdraw their money within 5 years.

### Risk and reward profile

**The main risks that could affect performance are set out below:**

- The value and income from the fund's assets will go down as well as up. This will cause the value of your investment to fall as well as rise. There is no guarantee that the fund will achieve its objective and you may get back less than you originally invested.
- The fund holds a small number of investments, and therefore a fall in the value of a single investment may have a greater impact than if it held a larger number of investments.
- The fund can be exposed to different currencies. Movements in currency exchange rates may adversely affect the value of your investment.
- The hedging process seeks to minimise, but cannot eliminate, the effect of movements in exchange rates on the performance of the hedged share class. Hedging also limits the ability to gain from favourable movements in exchange rates.
- In exceptional circumstances where assets cannot be fairly valued, or have to be sold at a large discount to raise cash, we may temporarily suspend the fund in the best interest of all investors.
- The fund could lose money if a counterparty with which it does business becomes unwilling or unable to repay money owed to the fund.
- Operational risks arising from errors in transactions, valuation, accounting, and financial reporting, among other things, may also affect the value of your investments.
- ESG information from third-party data providers may be incomplete, inaccurate or unavailable. There is a risk that the investment manager may incorrectly assess a security or issuer, resulting in the incorrect inclusion or exclusion of a security in the portfolio of the fund.

## Charges

The charges shown in the table are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

The entry and exit charges shown are the maximum figures and, in some cases you may pay less. The exit charge will reduce to 2% after the investment has been held for one year, and will subsequently reduce by 1% per year until year three. From year four, the exit fee is set at 0%.

The ongoing charge figure shown here is an estimate of the charges because the share class has only recently launched. The fund's annual report for each financial year will include details on the exact charges made. This figure may change from year to year. It excludes portfolio transaction costs.

The audit fees and custody transaction charges are borne by M&G until the fund size increases to above 200 million.
