

#### You are about to purchase a product that is not simple and may be difficult to understand.

#### What is this product?

- **Type:** The product is a Sub-fund of Challenge Funds (the Fund), an open-ended umbrella Unit Trust established by Mediolanum International Funds Limited as a UCITS pursuant to the provisions of the UCITS Regulations and governed by Irish law.
- Term: This is an open ended fund with no maturity date.
- Objectives:
  - The Sub-Fund's objective is to achieve, over a medium term investment horizon, capital stability and consistent returns irrespective of current market conditions and pay regular dividends.
  - The Sub-Fund invests in global fixed income securities (such as bonds issued by companies or governments), money market instruments (short term debt instruments) both directly and/or indirectly (e.g. by investing in derivatives).
  - The fixed income securities invested in may be rated investment grade (by a generally recognised international rating agency), below investment grade or unrated.
  - The Sub-Fund may use financial derivative instruments (FDIs) whose performance is linked to that of underlying security(s) or asset class(es). Their use may be for efficient portfolio management, hedging and/or direct Investment purposes.
  - The Sub-Fund may enter into securities lending transactions.
  - The Sub-Fund is actively managed (meaning that the Manager has full discretion over the composition of the Sub-Fund's portfolio of assets) and is not managed with reference to any benchmark.
  - The Manager has flexibility to change the Sub-Fund's asset allocation (% of the portfolio invested in bonds/FDIs etc) at any time and has discretion to select investments within each asset class.
  - The product is compatible with investors that can bear and/or afford to fully or partially lose the capital invested and are comfortable with no capital guarantee.
  - Income and gains generated by the unit class will be reinvested. No dividend will be paid.
  - Units can be bought or sold on any business day from the Fund's Administrator.

- **Intended retail investor:** This investment product has been developed for distribution in Europe and intended for retail investors (including those with a basic knowledge of financial instruments) who can accept the risk noted in the Risk Indicator section.

### What are the risks and what could I get in return?



- The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.
- We have classified this product as 2 out of 7, which is a low risk class.
- This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the capacity of the issuer to pay you.

#### **Costs over Time**
