This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

Product

Mercer Global Credit Fund (the "Fund")

a sub-fund of MGI Funds plc (the "Umbrella")

Class M1 EUR Hedged (IE00B86YYZ49) (the "Share Class")

Mercer Global Credit Fund is authorised in Ireland and regulated by the Central Bank of Ireland.

This product is managed by Mercer Global Investments Management Limited (the "Manager"), an indirect wholly owned subsidiary of Marsh McLennan and a member of the Mercer Global Investments group, which is authorised in Ireland and regulated by the Central Bank of Ireland as a UCITS Management Company. The Central Bank of Ireland is responsible for supervising the Manager in relation to this Key Information Document. What is this product?

Type

This product is a UCITS Investment Fund.

Term

This product has no fixed end date. However the Fund, at its absolute discretion, can redeem all the shares of the Fund under the circumstances set out in the prospectus.

Objectives

Investment objective The investment objective of the Fund is to provide income and capital growth.

Investment policies The Fund seeks to achieve its objective by investing in global credit markets. The Fund will primarily invest in a diversified portfolio of debt securities issued by companies and governments globally that are rated investment grade (i.e. BBB-, Baa3 or its credit equivalent, or above, as rated by an internationally recognized rating agency) at the time of purchase.

The Fund may invest in debt securities with various interest repayment terms, including fixed, floating, index-linked or inflation linked, and the debt securities may have no or varying maturities. Debt securities are securities which represent an obligation of the entity issuing the security to repay the amount received for the security plus interest.

The Fund may invest up to 25% of its net asset value in debt securities rated speculative grade at the time of investment (i.e. below investment grade, but at least B-, B3 or its credit equivalent, or above). No more than 25% of the Fund will be invested in emerging markets.

The Fund is actively managed and will seek to outperform the Bloomberg Customised Global Diversified Credit ex Subordinated Financials Index unhedged (the "Index") by 0.5% - 0.75%, gross of the fees of the Manager, the Investment Manager and the Distributor, but net of all other fees and expenses of the Fund, on average per annum over the medium to long term. The Investment Manager (or its delegates) may use its discretion to invest in, for example, securities, issuers, companies or sectors not included in the Index. The Index measures the performance of government and non-government treasury securities, corporate bonds, mortgage-backed securities (MBS), asset-backed securities (ABS), including both developed and emerging markets. The Fund does not intend to track the Index and there is no guarantee that the Sub-Fund will outperform the Index.

The Fund is anticipated to have a tracking error within a range of 0.25-2.25%, on an ex-post basis over the medium to long term under normal market conditions, although this is not a target or a restriction and there is no guarantee the Fund will stay within this range. Tracking error is an indicator of the degree to which the Fund's performance may deviate from that of the Index.

The Fund seeks to promote environmental characteristics within the meaning of Article 8 of the Sustainable Finance Disclosure Regulation ("SFDR").

The Fund will promote environmental characteristics by seeking to mitigate the impact of climate change through reducing the potential carbon footprint of the Fund. The Fund will seek to avoid exposure to companies that are deemed by the Investment Manager and its delegates as the worst carbon emitters with the lowest carbon transition potential, being companies whose carbon emissions intensity exceeds

3,000 tonnes/m\$USD revenue, or those companies that generate more than 1% of revenue from thermal coal extraction, arctic drilling, or oil tar sand mining.

The Fund's social characteristics are to avoid investment in companies that (i) are involved in the manufacture, distribution or sales of controversial weapons such as landmines, cluster munitions, chemical and biological weapons, nuclear weapons and (semi) automatic civilian firearms; or (ii) manufacture tobacco products or generate more than 50% of their revenue from tobacco distribution or sales.

The Fund seeks to avoid investing in companies considered as having material exposure to negative environmental impact, violation of international law/human rights, corruption and economic crime, recreational cannabis and the production of coal or coal-related products.

Further, the Fund will invest at least 25% in sustainable investments, being investments which, according to the Investment Manager's framework: (a) contribute positively to UN Sustainable Development Goals ("SDGs"); (b) do no significant harm to any environmental or social objective; and (c) follow good governance practices.

The Fund follows good governance standards in the selection of securities for investment and seeks to engage with any companies identified as violating UN Global Compact Principles ("UNGC") to remediate where possible. UNGC is a set of globally accepted standards on human rights, labour, the environment and anti-corruption.

The Fund may use financial derivative instruments (instruments for which the price is dependent on one or more underlying asset, "FDI") for hedging, efficient portfolio management and/or investment purposes. The Fund may take both long and short positions. Synthetic short positions will only be taken through the use of FDIs. The use of FDI may multiply the gains or losses made by the Fund on a given investment or on its investments generally.

The level of leverage for the Fund is not expected to exceed 300% of its net asset value, although higher levels of leverage may be experienced. The Fund's market exposure may vary in time and range from an anticipated maximum long position of 400% to an anticipated maximum short position of 300% of the net asset value of the Fund.

Your shares will be hedged with the aim of mitigating the effect of exchange rate fluctuations between the currency of your share class and the currencies of the Fund's underlying assets. The currency hedging approach may not be successful, so changes in exchange rates may adversely impact the value of your investment.

Redemption and Dealing You can buy and sell shares in the Fund on demand each day which is a bank business day in Ireland or the United Kingdom ("Dealing Day").

Distribution Policy The Share Class will not distribute dividends. Income and capital gains from the Fund are reinvested.

Intended retail investor

Investors who have at least a basic understanding of financial markets and the underlying investment instruments, who understand the risk of the Fund including the risk of capital loss and that the product should not constitute a complete investment plan and:

- have a long term investment horizon

- seek a product which promotes environmental and/or social characteristics

Depository The Fund's assets are held through its depository, State Street Custodial Services (Ireland) Limited.

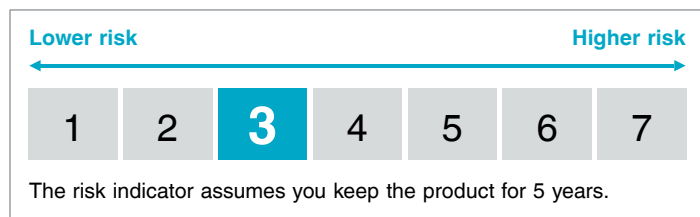

Risk Indicator

Performance scenarios

What happens if Mercer Global Investments Management Limited is unable to pay out?

The Manager is not responsible for meeting the obligations of the Fund to investors from its own assets. The Fund's assets are safeguarded by the Depository in accordance with applicable law. If the Fund is unable to pay out to investors due to its insolvency, investors will be unsecured creditors in the insolvency process and are likely to suffer a financial loss. Investors may also suffer a financial loss in the event of the Depository's insolvency or default (or that of any custody delegate). Investors in UCITS, such as the Fund, are not covered under the terms of the Irish statutory investor compensation scheme.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- in the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario,
- 10,000 EUR is invested.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product is designed for long term investment; you should be prepared to stay invested for at least 5 years. However, you can redeem your investment without penalty at any time during this period, or hold the investment longer. Redemptions are possible on any Dealing Day provided written instruction is received by the Administrator before 1pm (Irish time). It will typically take 3 Business Days for you to be paid.
