#### OBJECTIVES AND INVESTMENT POLICY

##### Objective

- Long term growth of your investment while integrating ESG characteristics

##### Main Investments

- At least 70% of the Fund's investments will be in company shares.

##### Investment Policy

- The Fund will invest in a concentrated portfolio of high quality, dominant franchises characterized by sustainable and high returns on operating capital, powerful intangible assets including brands, networks, licences and patents, and pricing power.
- As an essential and integrated part of the investment process, the Investment Adviser assesses relevant factors material to long- term sustainably high returns including ESG factors and seeks to engage with company management teams as part of this.
- Investments shall not knowingly include any company involved in the manufacturing or production of: tobacco; adult entertainment; civilian firearms; controversial weapons; coal; oil sands; Arctic oil; and gambling. - The Fund will measure its performance against the MSCI World Net Index (the "Benchmark"). The Fund is actively managed and is not designed to track the Benchmark. Therefore, the management of the Fund is not constrained by the composition of the Benchmark.

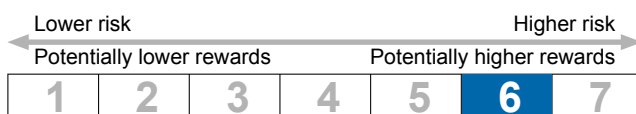
##### Other Information

- The Fund may invest up to 30% of its assets in investments that do not meet the above criteria.
- The Fund may also invest part of its assets in shares of companies from emerging market countries and other investments, which seek to generate a similar return to company shares without direct ownership of the company.
- The Fund may invest in derivatives, financial instruments which take their value indirectly from other assets. They rely on other companies to fulfil contractual obligations and carry more risk. Refer to the prospectus ('Use of Derivatives' section) for more details.
- Income will be included in the value of your shares.

##### Buying and selling shares

- Investors may buy and sell shares on any Luxembourg business day.
