What is this product?

Type

The product is a unit of the sub-fund AllRound Quadinvest Fund ESG (the sub-fund) of Multipartner SICAV (the "Umbrella Fund"), a "société d'investissement à capital variable" (SICAV) and is authorised as an undertaking for collective investment in transferable securities (UCITS) in accordance with Part I of the Law of 17 December 2010 on undertakings for collective investment (the "Law of 2010").

Term

The Fund has no maturity date. The Fund could be closed under the conditions set down in the current prospectus of the Fund.

Objectives

Investment Objective

The aim of the sub-fund ("Fund") is to achieve long-term capital growth. For this purpose, the Fund invests on a diversified basis in shares and other equity securities or rights of companies that come from recognised countries and observe the principles of sustainable development when conducting their business.

Investment Policy

The Fund invests in the shares of companies worldwide and in high-quality debt securities. These are securities which are extremely likely to be repaid in full on maturity and to pay interest on time and in full. The Fund is also free to invest in debt securities that can be converted into equities.

The Fund invests in floating and fixed-rate debt securities issued by governments and companies as well as in money market instruments.

When selecting the assets listed, the investment manager shall, with the support of the external certification body, take into consideration fulfilment of the criteria for sustainable financial products within the meaning of the Austrian Eco-label Guideline UZ 49. The ALLROUND QUADINVEST FUND ESG will thus be certified to the Austrian Eco-label UZ 49.

The Fund may use complex financial instruments (e.g. derivatives) to hedge its assets against currency risks as well as for efficient portfolio management purposes. In addition, it may invest a maximum 10% of its assets in other regulated investment funds.

The Fund promotes environmental and/or social characteristics in accordance with Article 8 of Regulation (EU) 2019/2088 (the "SFDR"), but does not have a sustainable investment as its objective.

The Fund is actively managed and does not follow any benchmark index. It has freedom of choice concerning investments and their weighting.

The Fund may invest up to 10% of its net assets in Chinese A shares. Investments in A shares are made either via the Renminbi Qualified Foreign Institutional Investor ("RQFII") system or via the Shanghai Exchange using Shanghai-Hong Kong Stock Connect or via the Shenzhen Exchange using Shenzhen-Hong Kong Stock Connect.

Share Class Policy:

Any income arising from this Share Class will be accumulated. Other share classes of the Fund may distribute income.

The Fund has several share classes. These may differ with regard to fees, minimum investment, use of revenues and investor qualification.

Processing of subscription and redemption orders

Investors may buy or sell the Fund on any bank working day in Luxembourg.

Intended retail investor

This Fund is aimed at retail and professional clients and eligible counterparties, who are seeking capital accumulation across categories and have a medium-term investment horizon. This Fund is aimed at investors with basic knowledge or experience of financial products. The investor is prepared to bear financial losses and does not require any capital guarantees.

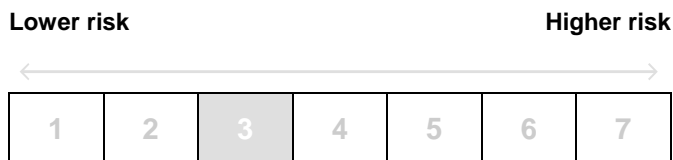

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 4 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose

money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

Be aware of currency risk. If you choose a foreign currency share class you will be exposed to currency risk and your final return will depend on the exchange rate between the foreign currency and your local currency. The risk is not considered in the indicator shown above.

Performance Scenarios

What happens if Carne Global Fund Managers (Luxembourg) S.A. is unable to pay out?

Costs over Time

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
