What is this product?

Type

The product is a unit of the sub-fund Atlanti Investment Companies Fund (the sub-fund) of Multirange SICAV (the "Umbrella Fund"), a "société d'investissement à capital variable" (SICAV) and is authorised as an undertaking for collective investment in transferable securities (UCITS) in accordance with Part I of the Law of 17 December 2010 on undertakings for collective investment (the "Law of 2010").

Term

The Fund has no maturity date. The Fund could be closed under the conditions set down in the current prospectus of the Fund.

Objectives

Investment Objective

The investment objective of this sub-fund is primarily to achieve long-term capital growth in the currency of account.

The strategy's market universe consists of listed securities and, in particular, listed investment companies, other regulated markets or multilateral trading systems that in turn invest solely or partially in shares, bonds, real estate or other assets that have no connection with the listed company itself other than through ownership.

Investment Policy

The sub-fund invests at least two thirds (2/3) in exchange-listed closed-end funds, also known as "investment trusts" or "investment companies". Investment trusts are public limited companies that can hold a range of assets, either directly or indirectly, including exchange-listed shares, government and corporate bonds, real estate and private equity, etc. These assets can be listed/registered/domiciled in any region. An investment company is a company that pools investors' capital. This pooled capital is invested, with the investors receiving a share of the profits and losses in proportion to their investment in the company.

The investment funds and investment companies described in this section are listed on a recognised exchange and may be bought and sold on that exchange.

The sub-fund invests a maximum of 10% in units of other UCITS and open-end UCIs within the meaning and subject to the restrictions of Section 5 of the General Part of the prospectus.

The sub-fund invests up to one third (1/3) in liquid assets and money market instruments of issuers worldwide as well as in sight deposits and overnight or callable deposits maturing in no more than 12 (twelve) months.

The sub-fund may use derivatives and special investment techniques, in particular foreign forward exchange contracts, for the purposes of efficient portfolio management and hedging.

The Fund is actively managed and does not follow any benchmark index. It has freedom of choice concerning investments and their weighting.

Share Class Policy:

Any income arising from this Share Class will be accumulated. Other share classes of the Fund may distribute income.

The Fund has several share classes. These may differ with regard to fees, minimum investment, use of revenues and investor qualification.

Processing of subscription and redemption orders

Investors may buy or sell the Fund on any bank working day in Luxembourg.

Intended retail investor

This Fund is aimed at retail and professional clients and eligible counterparties, who are seeking capital accumulation across categories and have a long-term investment horizon. This Fund is aimed at investors with basic knowledge or experience of financial products. The investor is prepared to bear financial losses and does not require any capital guarantees.

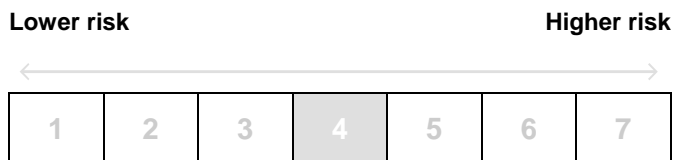

What are the risks and what could I get in return?

Risk Indicator



The risk indicator assumes you keep the product for 7 years.

The actual risk can vary significantly if you cash in at an early stage and you may get back less.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose

money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. If you choose a foreign currency share class you will be exposed to currency risk and your final return will depend on the exchange rate between the foreign currency and your local currency. The risk is not considered in the indicator shown above.

Performance Scenarios

What happens if Carne Global Fund Managers (Luxembourg) S.A. is unable to pay out?

Costs over Time

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario
