The Fund is authorised by the Central Bank pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended) and has been registered for sale in other EEA Member States. ## What is this product?

### Type:

This product is a UCITS Fund.

### Objectives:

The Fund aims to increase the value of your shares over the long-term by investing in a portfolio of global equity holdings that are involved with or derive benefit from Next Generation Mobility, these are companies which operate within the long-term trend of the proliferation of autonomous, electric and connected vehicles (Next Generation Mobility) that meet the Sustainable Criteria, as detailed in the "Sustainable Investment Criteria" section of the prospectus.

The Fund invests in a mixture of companies of different sizes, from different industries and does not focus on any specific country. The Fund may invest in companies of any market capitalisation but shall typically invest in companies that have market capitalisation greater than USD 500 million at time of purchase.

The Fund may invest directly in China A Shares through either Shanghai or Shenzhen Stock Connect.

The Fund selects investments using qualitative and quantitative analysis to identify companies of different sizes and from different industries that are involved with or derive benefit from Next Generation Mobility.

The Fund may invest up to 10% of its Net Asset Value (NAV) in REITS (Real Estate Investment Trusts). The Fund may invest up to 30% of its NAV in China A Shares (Shares in mainland China-based companies that trade on Chinese stock exchanges such as the Shanghai and the Shenzhen). A-shares are generally available for purchase by mainland citizens in China; foreign investment is subject to significant regulatory restrictions.

The Fund promotes environmental and social characteristics pursuant to Article 8 of SFDR.

As your shares are in US Dollars and the Fund is in US Dollars, currency exchange contracts are used to reduce the effect of changes in the currency exchange rate.

Any income earned on investments will be added to the value of investors' shares.

### Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances as described in the prospectus including if the Net Asset Value of the Fund does not exceed or falls below US\$75,000,000 (or such other amount as may be approved by the Directors).

The shares may be exchanged for shares in another sub-fund in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as umbrella fund with segregated liability between sub-funds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (BBH) is appointed as the depositary of NBIF.

### Intended retail investor:

This fund may be compatible with the needs of investors seeking a fund to deliver capital growth with an investment horizon of 3 years or more, as part of a diversified portfolio of investments. This is a medium to high risk product and investors should consider this when deciding the mix of portfolio investments. Investors who are unsure that they have the knowledge and experience to make informed investment decisions about this product or to construct a diversified portfolio should seek professional investment advice. The product is unlikely to be compatible with the needs of those investors seeking a single investment, or who require preservation of capital or to achieve a specified return by a particular date.

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact the ability for you to receive a positive return on your investment.

## What happens if NBAMIL is unable to pay out?

## What are the costs?

### Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs.
