What is this product?

Type:

This product is a UCITS Fund.

Objectives:

The Fund aims to increase the value of your shares by investing in the shares of companies listed or traded on recognised markets (defined in prospectus) worldwide, focusing on companies that are involved or derive benefit from the development and enhancement of digital and 5G connectivity (Innovative Technologies) that meet the Sustainable Criteria, as detailed in the "Sustainable Investment Criteria" section of the prospectus.

There can be no guarantee that the Fund will ultimately achieve its investment objective. The Fund invests in equity securities that are listed or traded on recognised markets (defined in the prospectus) globally (which may include emerging (less developed) market countries). The Fund invests in companies who focus on Innovative Technologies and:

- are incorporated or organized under the laws of a country in Asia, or that have a principal office in Asia;
- generally derive a majority of their incremental growth from (a) goods that are produced or sold, (b) investments made, or (c) services performed, in Asia;
- or generally hold a majority of their assets in Asia

The Fund may invest in companies of any market capitalisation but shall typically invest in companies that have one greater than USD 500 million at the time of purchase. The Fund may invest in:

- up to 30% of the Fund's Net Asset Value (NAV) in China A-shares listed on or dealt in the Shanghai or the Shenzhen Stock Exchanges;
- up to 10% of the Fund's NAV in fixed income securities

The Fund promotes environmental and social characteristics pursuant to Article 8 of SFDR.

As your shares are in Euro and the Fund is in US Dollars, currency exchange contracts are used to reduce the effect of changes in the currency exchange rate.

Income will be rolled up into the value of your investment.

Term:

The Fund has no fixed maturity date, however it may be terminated in certain circumstances as described in the prospectus including if the Net Asset Value of the Fund does not exceed or falls below US\$75,000,000 (or such other amount as may be approved by the Directors).

The shares may be exchanged for shares in another sub-fund in accordance with the terms of the Prospectus. Charges may apply.

Shares in the Fund can be bought or sold on any day defined as a Business Day in Prospectus.

NBIF is established as umbrella fund with segregated liability between sub-funds under Irish law.

Brown Brothers Harriman Trustee Services (Ireland) Limited (BBH) is appointed as the depositary of NBIF.

Intended retail investor:

This fund may be compatible with the needs of investors seeking a fund to deliver capital growth with an investment horizon of 3 years or more, as part of a diversified portfolio of investments. This is a medium to high risk product and investors should consider this when deciding the mix of portfolio investments. Investors who are unsure that they have the knowledge and experience to make informed investment decisions about this product or to construct a diversified portfolio should seek professional investment advice. The product is unlikely to be compatible with the needs of those investors seeking a single investment, or who require preservation of capital or to achieve a specified return by a particular date.

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class. This rates the potential losses from future performance at a medium level, and poor market conditions could impact the ability for you to receive a positive return on your investment.

This product also carries market risk, operational risk, counterparty risk, currency risk, and other risks. Please refer to the "Risk Factor" section of the Prospectus. This product does not include any protection from future market performance so you could lose some or all of your investment.

What happens if NBAMIL is unable to pay out?

How long should I hold it and can I take money out early?
