## Nordea 1 - Multi-Asset Plus Fund, BP-EUR Share Class

ISIN-Code: LU0607983896

The fund is managed by Nordea Investment Funds S.A., a company of the group Nordea Bank AB.

### Objectives and Investment Policy

The fund aims to provide an attractive absolute return by taking long or short exposures in a broad range of asset types such as:

- stocks and debt instruments from various economic sectors, industries, regions and countries,
- stocks and bonds indices,
- local currencies worldwide,
- interest rates, and
- commodities or commodities indices.

Such exposures may be achieved (i) via direct investments in those asset types, (ii) via the purchase of exchange traded funds or other collective investment vehicles or (iii) via the use of financial derivative instruments\*.

\* These are financial contracts the value of which depends on the market price of a reference item.

A total of 20 percent of the fund's net assets may be invested in mortgage and asset backed securities.

The fund is leveraged. This means:

- the cumulated contract values of long and short derivative instruments added to the market value of direct investments regularly exceed by several times the net assets of the fund.
- the fund is using statistical tools to daily estimate the maximal

loss\*\* that it could suffer over the next month in 99 out of 100 cases (the "value-at-risk" or VaR). Such VaR may not exceed 20% of the fund's net assets.

\*\* Statistical estimations are predictions of future performances but may significantly deviate from reality.

The fund implements a relatively higher return / higher risk investment strategy than the Multi-Asset Fund of the same umbrella (Nordea 1, SICAV).

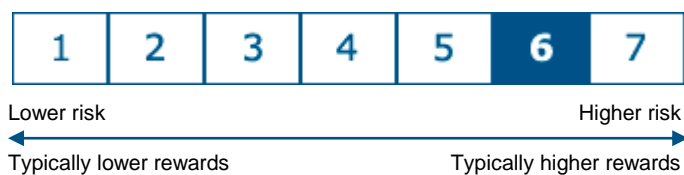
Nordea's Policy for Responsible Investment aims to create responsible returns with Responsibility throughout environmental, social and governance analysis, norm based screening and active ownership activities.

The fund may take part to a securities lending program. Any investor may redeem its shares in the fund on demand, on a daily basis. This fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

This share class is not distributing dividends. Income from investments are reinvested.

The fund is denominated in EUR. Investments in this share class settle as well in EUR.

### Risk and Reward Profile



The indicator measures the risk of price fluctuations in the fund certificates based on the last 5 years volatility and places the fund in category 6. This means that the purchase of units in the fund is connected to **high risk** of such fluctuations. Please note that category 1 does not mean a risk free investment. Historical data, such as is used in calculating the synthetic indicator, may not be a reliable indication of the future risk profile of the UCITS, why the category might change in the future.

Following risks are materially relevant to the UCITS but are not adequately captured by the synthetic indicator and may cause additional loss:

**Credit risk:** The default of the issuer of a debt instrument held by the fund.

**Liquidity risk:** Securities in the fund may be sold below their valuation due to insufficient liquidity in the market.

**Counterparty risk:** A counterparty may fail paying the proceeds related to the sale of securities by the fund or may fail delivering the securities purchased by the fund. A counterparty of the fund in an OTC derivative may fail satisfying its obligations towards the fund at any event of the OTC derivative agreement.

**Derivatives risk:** Derivatives are used to increase, lower or maintain the risk level of the fund. The strategy followed by the fund may fail resulting in significant losses for the fund.

**Operational risk:** Failures or delays in operational processes may negatively affect the fund.

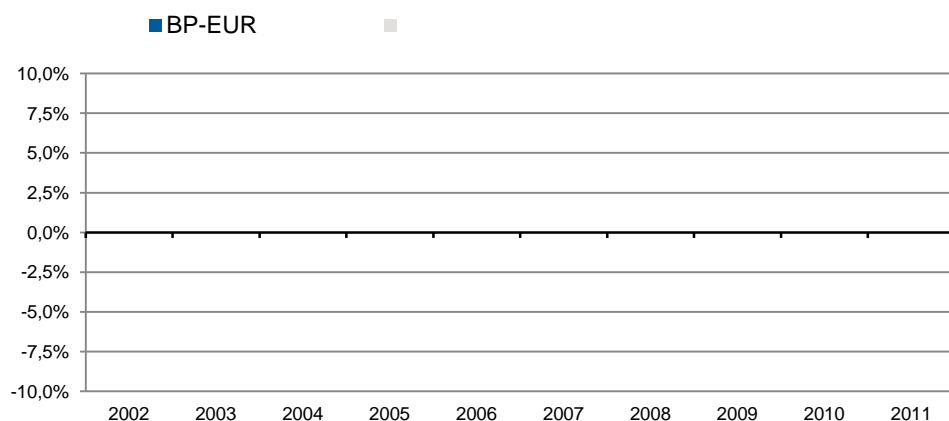
**Event risk:** Unforeseeable events such as devaluations, political events, etc...

**Charges**
