# Nordea 1 - Danish Mortgage Bond Fund, E-EUR Share Class

The fund is managed by Nordea Investment Funds S.A., a company of the group Nordea Bank AB.

### **Objectives and Investment Policy**

The fund aims to preserve Shareholders' capital and provide a stable rate of return by investing in Danish mortgage bonds.

The fund shall invest at least 2/3 of its total assets (after deduction of cash) in mortgage bonds issued by Danish public authorities or private borrowers that do business in Denmark.


The fund may invest up to 1/3 of its total assets in other instruments regardless of the type of issuer and its domicile. Investments in (i) money market instruments and (ii) bonds convertible into equity shares may respectively not exceed 1/3 and 1/4 of the fund's total assets. The fund may accessorily hold cash.

The fund does not compare its performance against any reference index. It may freely select the securities that it will invest in.

The fund may use financial derivative instruments\* mainly to: - protect itself against the depreciation of foreign currencies in its portfolio;

- mitigate the negative effect related to the default of the issuer(s) of

The indicator measures the risk of price fluctuations in the fund certificates based on the last 5 years volatility and places the fund in category 3. This means that the purchase of units in the fund is connected to **medium risk** of such fluctuations. Please note that category 1 does not mean a risk free investment. Nordea's Policy for Responsible Investment aims to create responsible returns throughout environmental, social and governance analysis, norm based screening and active ownership activities.

The fund may take part to a securities lending program. Any investor may redeem its shares in the fund on demand, on a daily basis. This fund may not be appropriate for investors who plan to withdraw their money within a period of 2 years.

This share class is not distributing dividends. Income from investments are reinvested.

The fund is denominated in DKK. Investments in this share class settle in EUR. DKK/EUR fluctuations may lead the performance in EUR of the share class to significantly deviate from the fund performance in DKK.

**Credit risk:** The default of the issuer of a debt instrument held by the fund.

**Liquidity risk:** Securities in the fund may be sold below their valuation due to insufficient liquidity in the market.

**Counterparty risk:** A counterpart may fail paying the proceeds related to the sale of securities by the fund or may fail delivering the securities purchased by the fund. A counterpart of the fund in an OTC derivative may fail satisfying its obligations towards the fund at any event of the OTC derivative agreement.

**Derivatives risk:** Derivatives are used to increase, lower or maintain the risk level of the fund. The strategy followed by the fund may fail resulting in significant losses for the fund.


**Operational risk:** Failures or delays in operational processes may negatively affect the fund.
