Objectives

Investment Objective The fund's objective is to provide shareholders with investment growth in the long term and create positive environmental impact. **Investment Strategy** In actively managing the fund's portfolio, the management team focuses on companies that based on a quantitative and qualitative evaluation of available data, are involved in economic activities that contribute substantially to at least one of the objectives of the EU ESG Taxonomy while not significantly harming other sustainable objectives and meeting minimum social safeguards, and that appear to offer superior growth prospects and investment characteristics.

Investment Policy The fund mainly invests in equities of companies from anywhere in the world. Specifically, the fund invests at least 75% of total assets in equities and equity-related securities. The fund will be exposed (through investments or cash) to other currencies than the base currency

Derivatives: The fund may use derivatives for hedging (reducing risks), efficient portfolio management and to seek investment gains.


