1. What is this product?

Product Type: The Fund is an actively managed Undertakings for Collective Investments in Transferable Securities (UCITS) ETF under Irish law in the form of a sub-fund of an Irish Collective Asset-management Vehicle (ICAV).

Maturity: This product has no specific maturity date. However, this product may be dissolved or merged, in which case you will be informed by any appropriate means provided for by the regulations.

Objectives: The objective of the Fund is to deliver the net total returns of a selection of listed equities, primarily from developed markets, with a view to contributing to the reduction of biodiversity impact in the agricultural and food sectors (the "Investment Universe").

Investment Policy: The Fund's investment universe consists mainly of equity securities from developed markets and related to the agriculture and food sectors. The Fund will invest at least 90% of its Net Asset Value in such equities. The Management Company first applies a "Liquidity and Size filter". Only the most liquid stocks and the largest stocks in terms of market capitalisation are kept in the selection. In order to achieve its sustainable investment objective of reducing biodiversity impact, the Management Company's quantitative model implements a thematic and impact rules-based exclusion approach that aims to assess the securities from the Investment Universe, based on ESG data provided by leading data providers. Securities that pass the "Liquidity and Size filter" go through: (i) a "Best-in-Class filter" which consists in identifying the 80% best ESG rated stocks for each sub-sector, followed by (ii) a "Normative and Exclusion filter" (e.g., breach of UN Global Compact Principles, serious controversies) on the selected securities to exclude securities that are not aligned with the E, S, G criteria and human rights of the Fund. Securities that pass all the above filters are referred to as the "Eligible Universe". The Management Company's optimisation procedure weights the Eligible Universe's equities while respecting certain constraints, including, but not limited to, an improvement, compared to the Investment Universe, of the E & S goals under the UN SDG framework, and a reduction of the portfolio's total GHG emissions compared to the Investment Universe. In certain market conditions, the composition of the Eligible Universe may make it impossible to perform the weighting optimisation while complying with the above list of constraints. In such circumstances, the Management Company may proportionally reduce some of the constraints until market conditions allow the optimization procedure to meet all the constraints.

Allocation of distributable amounts: Capitalization.

Intended Investors: Investors who understand the Fund's risks and plan to invest for the long term (minimum 5 years). The Fund is aimed at investors who: (i) are looking for a growth-oriented investment with a sustainable investment approach, (ii) are interested in international exposure to equity markets, either as a core investment or for diversification purposes, (iii) have a high risk profile and can withstand significant losses. The shares of this Fund have not been registered under the "US Securities Act of 1933" and may not be offered or sold directly or indirectly for the account or benefit of a "U.S. Person" as defined by US "Regulation S" and/or the "Foreign Account Tax Compliance Act".

In view of the provisions of EU Regulation No. 833/2014 and EU Regulation 2022/398 the subscription of shares in this Fund is prohibited to any Russian or Belarusian national, any natural person residing in Russia or Belarus or any legal person, entity or body established in Russia or Belarus except nationals of a Member State and natural persons holding a temporary or permanent residence permit in a Member State.

2. What are the risks and what could I get in return?

3. What happens if the Issuer is unable to pay out?

4. What are the costs?

Reduction in yield (RIY) shows the impact of the total costs you pay on the return on investment you could achieve. Total costs take into account one-off, ordinary and ancillary costs.

The tables show the amounts deducted from your investment to cover the various types of costs.
