Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

The Central Bank of Ireland ("CBI") is responsible for supervising PGIM Funds plc in relation to this Key Information Document.

PGIM Funds plc (the "Company") is managed by PGIM Investments (Ireland) Limited (the "Manager"). The Company and the Manager are each authorised in Ireland and regulated by the CBI.

This Key Information Document is accurate as at 30 November 2023.

What is this product?

Type

This product is a sub-fund of an open-ended umbrella fund authorised by the Central Bank of Ireland pursuant to the UCITS Regulations (as amended).

Term

The Fund has no maturity date.

Objectives

The Fund aims to achieve a return through a combination of current income and capital appreciation while preserving invested capital. The Fund will use the relative value approach through which it will seek to identify and capture market inefficiencies within the emerging market fixed income and foreign exchange markets with an actively-managed approach.

The Fund refers to the J.P. Morgan EMBI Global Diversified Index (the "Benchmark"). While the Fund is actively managed, the Benchmark will be used for risk management purposes and performance comparison purposes.

The Fund will seek to achieve its objective by investing in a diversified portfolio consisting of hard currency (US Dollar, Sterling, Euro and Yen) emerging market sovereign and corporate bonds, the use of derivative transactions (such as interest rate swaps) and, to a lesser extent, locally denominated emerging market securities. The Fund is expected to invest principally in the sovereign debt of emerging market countries that is denominated in hard currencies.

The Fund's investments may include debt securities (including sovereign, quasisovereign, senior and subordinated corporate bond obligations and loan participation notes) and warrants.

For investment, risk management or hedging purposes, the Fund's investments may also include derivative transactions (futures, options, forward foreign currency contracts, swaptions, credit default swaps, total return swaps, and interest rate swaps) the underlying reference assets for which will be bonds, interest rates, indices and currencies. The Fund may also engage in efficient portfolio management techniques.

The Fund may not be leveraged in excess of 100% of its net asset value, through the use of derivatives.

The debt securities in which the Fund invests may be investment grade, below investment-grade, and non-rated securities (in each case without limit) issued by issuers in emerging market countries. The Fund may also invest in equity-related

instruments, cash and short-term investments denominated in local emerging market currencies, US Dollars, Sterling, Euros, and Yen.

The Fund seeks to avoid investing in issuers that engage in activities that are not in compliance with certain socially-responsible investment criteria set forth by PGIM Fixed Income's environmental, social and governance committee.

It is not currently anticipated that dividends will be declared in respect of the Class. Net investment income attributable to the Class is expected to be retained by the Fund, which will increase the net asset value per share of the Class.

Investors can buy and sell their shares on each business day of the Fund.

The shares are denominated in Japanese Yen, and the Investment Manager aims to hedge the currency exposure of the shares against the US Dollar. The base currency of the Fund is the US Dollar.

The Fund is intended for investors who want to take a long or short-term exposure to a diversified portfolio consisting primarily of hard currency (US Dollar, Sterling, Euro and Yen) denominated emerging market sovereign and corporate bonds, and to a lesser extent, currencies and local currency emerging market securities. Investors of the Fund should be prepared to accept the risks associated with an investment of this type, which may include the risk of high volatility.

The Fund's assets are held through the Company's Depositary, which is State Street Fund Services (Ireland) Limited. You can obtain further and other practical information, including the current prospectus and supplement, net asset value per share of the Fund, and most recent financial statements from the applicable distributor or from our website: www.pgim.com/ucits. All such documents are available in English on paper and are free of charge on request. The prospectus is also available in German. The assets of the Fund are segregated from other funds in the Company. This means that the assets of one fund cannot be used to meet the liabilities of another fund. This Key Information Document describes the Fund only; the prospectus and the annual and interim reports and accounts are prepared for the Company rather than the Fund. You may at any time switch all or some of your shares in the Fund for shares in any other fund of the Company and may obtain further information about this from the Conversion of Shares section of the prospectus.

Intended Retail Investor

The Fund is intended for retail and institutional investors. The investor's objective for this investment should be aligned with that of the product as outlined above.

The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 3 out of 7, which is a medium-low risk. This rates the potential losses from future performance at a medium-low level.

You will receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

Performance Scenarios

How long should I hold it and can I take money out early?

Recommended holding period: 5 years.

This product has no required holding period; however it is recommended that you hold the product for at least 5 years. The product is designed to be held over the medium term and investors should not expect to obtain short term gains as performance may be more volatile over shorter periods. This product has an open-ended structure, allowing you to redeem your shares before the recommended holding period. There are no fees or penalties charged by the product or the issuer for cashing out prior to the end of the recommended holding period.
