PGIM Funds plc (the "Company") is managed by PGIM Investments (Ireland) Limited (the "Manager"). The Company and the Manager are each authorised in Ireland and regulated by the CBI.

What is this product?

This product is a sub-fund of an open-ended umbrella fund authorised by the Central Bank of Ireland pursuant to the UCITS Regulations (as amended).

Term

The Fund has no maturity date.

Objectives

The Fund aims to outperform ICE BofA US 3-Month Treasury Bill Index (the "Benchmark") over a full market cycle on a total return basis. There can be no assurance that the investment objective will be achieved. The Benchmark is being used for performance comparison purposes only.

The Fund will be actively managed and seek(s) to add value through a flexible investment strategy, investing in a variety of securities and instruments and using a variety of investment techniques, which may include managing duration, credit quality, yield curve positioning, and currency exposure, as well as sector and security selection.

There are no constraints on the Fund's ability to invest in below investment grade securities. The effective duration of the Fund will generally be within plus or minus one year of the duration of ICE BofA US 3-Month Treasury Bill Index.

The Fund's investments may be issued by either US or non-US issuers, may be fixed or floating rate in nature, and may be US dollar or non-US dollar denominated.

The Fund may use (to a significant extent) for investment, risk management or hedging purposes, exchange traded and over-the-counter derivatives including futures and options, credit default swaps, forward contracts, total return and interest rate swaps, currency swaps, and swap options (swaptions), the underlying reference assets for which will be bonds, in which the Fund may invest directly, interest rates, currencies and indices. The Fund may also engage in efficient portfolio management techniques.

The Fund may not be leveraged in excess of 1500% of its net asset value, through the use of derivatives.

The Investment Manager has determined that the Fund promotes sustainability characteristics, due to its use of its internal evaluation process, which analyses securities based on ESG criteria established by PGIM Fixed Income's ESG committee, and is therefore classified under Article 8 of the Sustainable Finance Disclosure Regulation ("SFDR"). The Fund seeks to avoid investing in issuers that engage in activities that are not in compliance with certain socially-responsible investment criteria set forth by the ESG committee. Although the Fund promotes sustainability characteristics, it does not have sustainable investment as its investment objective.

All net investment income, if any, will be declared as dividends. Net realised gains attributable to the distribution class shares are expected to be retained by the Fund.

Investors can buy and sell their shares on each business day of the Fund.

The shares are denominated in US Dollars. The base currency of the Fund is the US Dollar.

The Fund is intended for investors who want to take a long or short-term exposure to a diversified portfolio consisting primarily of income-producing debt securities of global entities and organisations. Investors of the Fund should be prepared to accept the risks associated with an investment of this type.

The Fund's assets are held through the Company's Depositary, which is State Street Fund Services (Ireland) Limited. You can obtain further and other practical information, including the current prospectus and supplement (including the SFDR annex), net asset value per share of the Fund, and most recent financial statements from the applicable distributor or from our website: www.pgim.com/ucits. All such documents are available in English on paper and are free of charge on request. The prospectus is also available in German. The assets of the Fund are segregated from other funds in the Company. This means that the assets of one fund cannot be used to meet the liabilities of another fund. This Key Information Document describes the Fund only, the prospectus and the annual and interim reports and accounts are prepared for the Company rather than the Fund. You may at any time switch all or some of your shares in the Fund for shares in any other fund of the Company and may obtain further information about this from the Conversion of Shares section of the prospectus.

The Fund reclassified from Article 6 to Article 8 on 12 June 2023.

Intended Retail Investor

The Fund is intended for retail and institutional investors. The investor's objective for this investment should be aligned with that of the product as outlined above.

What are the risks and what could I get in return?

The risk indicator assumes that you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.

We have classified this product as 2 out of 7, which is a low risk. This rates the potential losses from future performance at a low level.

Performance Scenarios

Recommended holding period: 5 years.

This product has an open-ended structure, allowing you to redeem your shares before the recommended holding period.
