#### **PORTFOLIO ASSETS**

The Compartment mainly invests in equities of companies that are domiciled, or do most of their business, in Asian countries, with the exception of Japan. The Compartment invests in emerging markets and Mainland China.

#### **DERIVATIVES AND STRUCTURED PRODUCTS**

The Compartment may use derivatives to reduce various risks (hedging) and for efficient portfolio management, and may use structured products to gain exposure to portfolio assets.

#### **INVESTMENT PROCESS**

In actively managing the Compartment, the investment manager uses a combination of market and fundamental company analysis to select securities that it believes offer favourable growth prospects at a reasonable price. The investment manager may invest in issuers with any environmental, social, and governance (ESG) profile. It methodically exercises voting rights and may engage with issuers in order to positively influence ESG practices. The performance of the Compartment is likely to be significantly different from that of the benchmark, because the Investment Manager has significant discretion to deviate from its securities and weightings.

#### Terms to understand

**Derivatives** Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

Emerging markets Markets of less economically developed nations, such as some nations in Asia, Africa, Eastern Europe and Latin America. Equities Securities that represent a share in the business results of a company.

Structured products Securities similar to derivatives, but with defined risk or performance characteristics.

#### Other characteristics

Designed for investors who understand the risks of this Compartment and plan to invest for 5 year(s) or more. This is an accumulation share class, meaning any income earned is retained in the share price. It is also a hedged share class, which means that it is designed to reduce, but not cancel out, the currency risk between the Compartment currency and the Share Class currency. Orders to buy, switch or redeem shares are ordinarily processed on any day that is a full bank business day in Luxembourg.

The Share Class is assigned to this risk category because of the price variations resulting from its currency and the nature of the Compartment's investments and strategy. - Financial Derivatives risk: the leverage resulting from derivatives amplifies losses in certain market conditions.

# **Charges**
