# WHAT IS THIS PRODUCT?

#### Туре

Pictet CH - Sovereign Short-Term Money Market USD is a subfund of an open-ended contractual investment fund with segregated liability between subfunds and is authorised as an other fund for traditional investment in Switzerland.

#### Term

This product has no maturity date. The Fund has been established for an indefinite period. However, it may be wound up at any time by the Management Company or the custodian bank. Dividend distribution policy: Distributed. You may redeem your investment upon demand. Dealing frequency: Daily.

#### Objectives

Generate a stable return and preserve the value of your investment, while taking into account environmental, social and governance (ESG) criteria.

#### Reference Index

The fund is managed without reference to an index.

#### **Portfolio Assets**

The fund invests primarily in government instruments and highly rated short maturity government bonds. These investments are denominated or hedged in US dollars so that the exchange rate risk is non-existent or limited.

**Derivatives and Structured Products** 

The fund may use derivatives to reduce various risks (hedging), but not to reduce portfolio management costs or increase exposure to certain assets.

#### **Compartment Currency**

#### **Investment Process**

To actively manage the fund, the investment manager uses market, interest rate and credit risk analysis to select securities that it believes offer the best risk-adjusted returns. The manager constructs its portfolio in accordance with Pictet Asset Management's responsible investment principles. It mainly selects investments with a high ESG profile. The fund's investment policy is similar to that of an "Article 8" financial product according to the European Union's regulations on sustainable investment information.

#### Intended retail investor

Suitable for investors with all levels of knowledge and/or experience, seeking capital preservation, capital growth, and income distribution, and who have an investment horizon of less than 1 year. The product does not have any capital guarantee and up to 100% of their capital is at risk.

# WHAT HAPPENS IF PICTET ASSET MANAGEMENT S.A. IS UNABLE TO PAY OUT?

A default of Pictet Asset Management S.A. will therefore have no impact on the value of your investment in the product.

#### Costs over time
