## Objectives and investment policy

### OBJECTIVE

To increase the value of your investment, through income and investment growth. A sustainable strategy of low carbon emission exposure in view of achieving the objectives of the Paris Agreement is also applied.

### REFERENCE INDEX

FTSE WGBI All Maturities (USD hedged), an index that does not take into account environmental, social and governance (ESG) criteria. Used for risk monitoring, performance objective and performance measurement.

### PORTFOLIO ASSETS

The Compartment mainly invests in government bonds issued by countries that are reducing their greenhouse gas emissions and carbon intensity (net of land and forestry management) or in the opinion of the investment manager are in the process of implementing policies that may lead to a meaningful improvement. The Compartment may invest worldwide, including in emerging markets and Mainland China, and can invest across any currency. These may include Sharia-compliant bonds. Some of these investments may be below investment grade.

### DERIVATIVES AND STRUCTURED PRODUCTS

The Compartment may use derivatives to reduce various risks (hedging) and for efficient portfolio management, and may use derivatives and structured products to gain exposure to portfolio assets.

### INVESTMENT PROCESS

In actively managing the Compartment, the investment manager selects countries based on their carbon emissions reduction and following uses a combination of macroeconomic, market and issuer analysis to build a diversified portfolio of securities it believes offer the best risk-adjusted returns. The Compartment's management approach uses strict risk controls. There may be engagement with countries to positively influence climate related matters. For further information, please refer to our exclusion framework in the Responsible Investment policy\* SFDR product category Article 9. The performance of the Compartment is likely to be significantly different from that of the benchmark, because the Investment Manager has significant discretion to deviate from its securities and weightings.

### Terms to understand

**Bonds** Securities that represent an obligation to repay a debt, along with interest.

**Derivatives** Financial instruments whose value is linked to one or more rates, indexes, share prices or other values.

**Emerging markets** Markets of less economically developed nations, such as some nations in Asia, Africa, Eastern Europe and Latin America.

**Paris Agreement** An international treaty on climate change that aims to limit the rise of temperature to 1.5 degrees Celsius globally.

**Structured products** Securities similar to derivatives, but with defined risk or performance characteristics.

**Sharia-compliant bonds (Sukuk)** Unlike a conventional bond, Sukuk are structured as an ownership interest in an underlying asset funding arrangement.

### Other characteristics

Designed for Investors who understand the risks of this compartment and plan to invest for 3 years or more. This is an accumulation share class, meaning any income earned is retained in the share price. It is also a hedged share class, which means that it is designed to reduce, but not cancel out, the currency risk between the Compartment currency and the Share Class currency. Orders to buy, switch or redeem shares are ordinarily processed on any day that is a full bank business day in Luxembourg.

## Risk and reward profile



The Share Class is assigned to this risk category because of the price variations resulting from its currency and the nature of the Compartment's investments and strategy. The risk category shown is based on historical data and may not be a reliable indication for the future risk profile of the Share Class. It is not a target or a guarantee and may change over time. The lowest category does not mean a risk-free investment. The Compartment offers no capital guarantee or asset protection measures.

The Compartment may be exposed to the following risks which are not adequately captured by the synthetic risk indicator and may negatively impact its value:

- **Liquidity risk:** markets with low volumes result in difficulties valuing and/or trading some assets.
- **Counterparty risk:** losses occur when a counterparty does not honour its obligations related to contracts such as over-the-counter derivatives.
- **Credit risk:** sudden losses may occur when issuers of debt securities default on their payment obligations.
- **Investments in emerging markets** are generally more sensitive to risk events, such as changes in the economic, political, fiscal and legal environment, as well as fraud.
- **Investments in Mainland China** may be subject to capital restrictions and trading quotas (e.g. QFII and RQFII regimes). The Compartment may encounter difficulties or delays in enforcing its rights in the event of disputes.
- **Contingent Convertible ("CoCo") investments** may result in losses when regulatory or issuer-motivated triggering events cause a total loss of the investment or a conversion to equity.
- **Operational risk:** losses resulting from human errors, system failures, incorrect valuation and safekeeping of assets.
- **RMB currency risk:** the RMB is not currently a freely convertible currency and is subject to exchange control policies and restrictions.
- **Investing in distressed securities** The recovery of investments in distressed or defaulted debt securities is subject to uncertainty related to court orderings and corporate reorganisations among other things. Companies which issued the debt that has defaulted may also be liquidated.
- **Sustainability risk:** ESG related risk events or conditions could cause a material negative impact on the value of the investment if they were to occur.

## Charges

The charges you pay are used to cover the costs of running the Compartment, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.

The **entry, conversion** and **exit charges** shown are maximum figures. In some cases you may pay less. You can find this out from your financial adviser or fund distributor.

The **ongoing charges** shown here are an estimate of future charges. This figure may vary from year to year. It excludes performance fees and portfolio transaction costs, except in the case of an entry/exit charge paid by the Compartment when buying or selling units/shares in another collective investment undertaking.
