#### PORTFOLIO ASSETS

The Compartment mainly gains exposure, directly or indirectly, to equities, bonds, money market instruments, commodities (including precious metals), real estate and currencies from emerging markets, including Mainland China. The Compartment can invest across any currency, credit quality and economic sector. The Compartment may gain exposure to portfolio assets by investing in funds, which may incur a duplication of certain fees, and derivatives

#### **DERIVATIVES AND STRUCTURED PRODUCTS**

The Compartment may use derivatives to reduce various risks (hedging) and for efficient portfolio management, and may use derivatives and structured products to gain exposure to portfolio assets.

#### INVESTMENT PROCESS

In actively managing the Compartment, the investment manager uses a risk-managed approach to seek additional performance opportunities, and pursues a flexible asset allocation strategy. The investment manager may invest in issuers with any environmental, social, and governance (ESG) profile. It methodically exercises voting rights and may engage with issuers in order to positively influence ESG practices. The Compartment is not constrained by the benchmark and the similarity of its performance to the benchmark may vary.

#### Terms to understand

Bonds Securities that represent an obligation to repay a debt, along with interest. **Derivatives** Financial instruments whose value is linked to one or more rates, indexes, share prices or other values

Emerging markets Markets of less economically developed nations, such as some nations in Asia, Africa, Eastern Europe and Latin America.

Equities Securities that represent a share in the business results of a company. Money market instruments Financial instruments designed to provide stable value, interest and a very low risk of loss, as well as being readily convertible into cash. Structured products Securities similar to derivatives, but with defined risk or performance characteristics.

#### Other characteristics

Designed for Investors who understand the risks of this Compartment and plan to invest for 5 years or more. This is an accumulation share class, meaning any income earned is retained in the share price. It is also a hedged share class, which means that it is designed to reduce, but not cancel out, the currency risk between the Compartment currency and the Share Class currency. Orders to buy, switch or redeem shares are ordinarily processed on any day that is a full bank business day in Luxembourg.

# Risk and reward profile



The Share Class is assigned to this risk category because of the price variations resulting from its currency and the nature of the Compartment's investments and strategy. The Compartment may be exposed to the following risks which are not adequately captured by the synthetic risk indicator and may negatively impact its value:

- Financial Derivatives risk: the leverage resulting from derivatives amplifies losses in certain market conditions.
- Liquidity risk: markets with low volumes result in difficulties valuing and/or trading
- Counterparty risk: losses occur when a counterparty does not honour its obligations related to contracts such as over-the-counter derivatives.
- Credit risk: sudden losses may occur when issuers of debt securities default on their payment obligations.
- Investments in emerging markets are generally more sensitive to risk events, such as changes in the economic, political, fiscal and legal environment, as well as
