What is this product?

Type This product is a UCITS sub-fund of a variable capital umbrella investment company with segregated liability between sub-funds authorised by the Central Bank of Ireland pursuant to the European Communities (Undertakings for Collective Investment in Transferable Securities) Regulations 2011, as amended.

Investment Policy

Investment Policy The fund aims to achieve this objective by investing in a combination of fixed income securities (which are similar to loans and pay a fixed or variable rate of interest) issued by companies or governments that are economically tied to Asian countries (excluding Japan) and related derivatives on such fixed income securities. The fund is considered to be actively managed in reference to the JPMorgan JACI Non-Investment Grade Index (the "Index") by virtue of the fact that the Index is used for duration measurement, calculating the global exposure of the fund using the fund's securities may be components of and may have similar weightings to the Index. However, the Index is not used to define the portfolio composition of the fund or as a performance target and the fund may he wholly invested in securities which or as a performance target and the fund may be wholly invested in securities which are not constituents of the Index.
