What is this product?

Type

This is an open ended UCITS fund.

Term

There is no maturity date of the fund.

Investment objective

The fund aims to provide capital growth in excess of the FTSE Italia All-Share (TR) Index after fees have been deducted over a three to five year period by investing in equities of Italian companies.

The fund is actively managed and invests at least 70% of its assets in a concentrated range (typically fewer than 50 companies) of equities of Italian companies. The fund invests at least 25% of these assets (which corresponds to 17.5% of the fund's assets) in equities of Italian companies that are not included in FTSE MIB index or other equivalent indices and at least 5% of these assets (which corresponds to 3.5% of the fund's assets) in equities of Italian companies that are not included in the FTSE MIB and FTSE MID CAP indexes or other equivalent indices.

The fund may invest up to 10% of its assets in equities issued by, or entered into with, the same company or companies belonging to the same group.

The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash (subject to the restrictions provided in the prospectus).

The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets.

Benchmark: The fund's performance should be assessed against its target benchmark being to exceed the FTSE Italia All-Share (TR) Index and compared against the Morningstar Italy Equity Category. The fund's

investment universe is expected to overlap materially with the components of the target benchmark. The comparator benchmark is only included for performance comparison purposes and does not determine how the investment manager invests the fund's assets. The investment manager invests on a discretionary basis and is not limited to investing in accordance with the composition of the target benchmark. The benchmark(s) does/do not take into account the environmental and social characteristics or sustainable objective (as relevant) of the fund. Other Information

The fund maintains a higher overall sustainability score than the FTSE Italia All-Share (TR) index, based on the investment manager's rating criteria.

The fund does not directly invest in certain activities, industries or groups of issuers above the limits listed under "Sustainability Information" on the fund's webpage, accessed via www.schroders.com/en/lu/private-investor/gfc

Dealing Frequency: You may redeem your investment upon demand. This fund deals daily.

Distribution Policy: This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.

Intended retail investor

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. This investment should form part of a varied investment portfolio. This product is suitable for general sale to retail and professional investors through all distribution channels with or without professional advice.

What are the risks and what could I get in return?

Risks



The risk indicator assumes you keep the product for 3 years.

We have classified this product as 5 out of 7, which is a medium-high risk class.

The fund is in this category because it can take higher risks in search of higher rewards and its price may rise and fall accordingly.

If the fund is terminated or wound up, the assets will be liquidated and you will receive an appropriate share of any proceeds but you may lose part or all of your investment. You are not covered by the Luxembourg compensation scheme.

What are the costs?

Costs over time

The Reduction in Yield (RIY) shows what impact the total costs you pay will have on the investment return you might get. The total costs take into account one-off, ongoing and incidental costs.

The amounts shown here are the cumulative costs of the product itself, for two different holding periods. They include potential early exit penalties. The figures assume you invest EUR 10 000,00. The figures are estimates and may change in the future.
