# What is this product?

This is an open ended UCITS fund.

#### Term

There is no maturity date of the fund.

#### Investment objective

The fund aims to provide capital growth in excess of the MSCI Nordic Smaller Companies (Net TR) Index after fees have been deducted over a three to five year period by investing in equities of small-sized Nordic

The fund is actively managed and invests at least two-thirds of its assets in equities of small-sized Nordic companies. These are companies which, at the time of purchase, are considered to be in the bottom 30% by market capitalisation of the Nordic equities market.

Portfolio construction is based on fundamental research, with a bias towards investing in well-managed, innovative businesses that can generate cash and grow sustainably in the long term.

The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash (subject to the restrictions provided in appendix I of the prospectus).

The fund may use derivatives with the aim of reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying

Benchmark: The fund's performance should be assessed against its target benchmark being to exceed the MSCI Nordic Smaller Companies (Net TR) Index and compared against the Morningstar Nordic Small/Mid-Cap Equity Category. The fund's investment universe is expected to overlap materially with the components of the target benchmark. The comparator benchmark is only included for performance comparison purposes and does not determine how the investment manager invests the fund's assets. The investment manager invests on a discretionary basis and there are no restrictions on the extent to which the fund's portfolio and performance may deviate from the target benchmark. The benchmark(s) does/do not take into account the environmental and social characteristics or sustainable objective (as relevant) of the fund. Dealing Frequency: You may redeem your investment upon demand. This fund deals daily.


Distribution policy: This share class pays a semi-annual distribution at a variable rate based on gross investment income.

# What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?
