This fund is managed by Schroder Investment Management (Luxembourg) S.A., which is a member of the Schroders Group.

Objectives and Investment Policy

Objectives

The fund aims to provide income and capital growth.

The fund aims to deliver a target income of 8% per year but this is not guaranteed and could change depending on market conditions.

Investment Policy

At least two-thirds of the fund (excluding cash) will be invested in shares of companies worldwide, which offer a high dividend income and are selected for their long-term income and growth potential. The fund has no bias to any particular industry or size of company.

The fund generates its income from two sources; dividends and cash received from selling some of the potential capital growth on the shares held in the fund.

The fund may also invest in other financial instruments and hold cash on deposit. Derivatives may be used to achieve the investment objective and to reduce risk or manage the fund more efficiently.

Benchmark

This share class is not managed with reference to a financial index.


Dealing Frequency

You may redeem your investment upon demand. This fund deals daily.

Distribution Policy

This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.

Risk and Reward Profile



The risk and reward indicator

Other particular risks

Capital risk / distribution policy: fixed distributions may be paid out of capital if investment income is less than the fixed distribution amount.

Capital risk / yield: The fund is obliged to make regular yield payments to investors and, if its income is insufficient to cover these payments, these payments may reduce the fund's capital.

Currency risk / hedged share class: Changes in exchange rates will affect the returns on your investment. The aim of this euro hedged share class is to provide you with the performance returns of the fund's investments by reducing the effects of exchange rate fluctuations between euro and the fund's base currency US dollar.

Financial techniques / derivatives: The derivative strategy is applied repeatedly over three-monthly periods. This strategy will increase the income paid to investors and reduce the volatility of returns, but there is the potential the performance or capital value may be eroded

Operational risk / third parties: The fund's operations depend on third parties and it may suffer disruption or loss in the event of their failure.


The charges you pay are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.
