### What is this product?

#### Type

This is an open ended UCITS fund.

#### Term

There is no maturity date of the fund.

#### Investment objective

The fund aims to provide income and capital growth of ICE BofA AA-BBB ABS Index, before fees have been deducted\* over a three to five year period by investing in securitised assets issued by entities worldwide. \*For the target return after fees for each share class please visit the Schroder webpage:

The fund is actively managed and invests at least two-thirds of its assets in securitised investments including but not limited to asset-backed securities (ABS), residential mortgage-backed securities (MBS) and commercial mortgage-backed securities (CMBS). The fund may also invest in collateralised loan obligations (CLOs).

The fund may invest up to 100% of its assets in ABS, MBS and CMBS issued worldwide with an investment grade and sub-investment grade credit rating (as measured Standard & Poor's or any equivalent grade of other credit rating agencies). Underlying assets of the asset-backed securities may include credit card receivables, personal loans, auto loans, transportation finance and small business loans.

The fund may invest up to 30% of its assets in securities with a sub-investment grade credit rating (as measured Standard & Poor's or any equivalent grade of other credit rating agencies).

The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash (subject to the restrictions provided in the prospectus).

The fund may use derivatives with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets.

**Benchmark:** The fund's performance should be assessed against its target benchmark of ICE BofA AA-BBB ABS Index and compared against the Bloomberg Barclays 1-5yr Global Credit index (Hedged to USD). The comparator benchmark is only included for performance comparison purposes and does not determine how the investment manager invests the fund's assets. Whilst the fund's investments are generally expected to deviate significantly from the components of the comparator benchmark, dependent on the investment manager's views, the fund's investments may overlap with them. The investment manager invests on a discretionary basis and there are no restrictions on the extent to which the fund's portfolio and performance may deviate from the comparator benchmark. The benchmark(s) does/do not take into account the environmental and social characteristics or sustainable objective (as relevant) of the fund.

**Dealing Frequency:** You may redeem your investment upon demand. This fund deals daily.


**Distribution Policy:** This share class pays a quarterly distribution at a variable rate based on gross investment income.

#### Intended retail investor

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. This investment should form part of a varied investment portfolio. This product is suitable for general sale to retail and professional investors through all distribution channels with or without professional advice.

# What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?
