## What is this product?

#### Туре

This is an open ended UCITS fund.

#### Term

There is no maturity date of the fund.

#### Investment objective

The fund aims to provide income and capital growth of 50% JP CLOIE index + 50% ICE BofA CABS index before fees have been deducted\* over a three to five year period by investing in securitised bonds issued by entities worldwide. \*For the target return after fees for each share class please visit the Schroder webpage: https://www.schroders.com/en/lu/ private-investor/investing-withus/after-fees-performance-targets/

The fund is actively managed and invests at least two-thirds of its assets in securitised bonds including, but not limited to, asset-backed securities (ABS), agency and non-agency residential mortgage-backed securities (MBS) including forward-settling securities such as to be announced (TBA) trades, commercial mortgage-backed securities (CMBS), collateralised loan obligations (CLOs) and credit risk transfer securities (CRTs). Underlying assets of the asset-backed securities may include credit card receivables, personal loans, auto loans, transportation finance and small business loans. The fund may also invest in fixed and floating rate securities issued by governments, government agencies, supra-nationals and companies worldwide.

The fund's strategy will have an overall duration of between zero and four years, but this does not preclude the fund from investing in bonds with a duration above four years.

The fund may invest up to 100% of its assets in bonds issued worldwide with an investment grade or sub-investment grade credit rating (as measured by Standard & Poor's or any equivalent grade of other credit rating agencies for rated securities and implied Schroders ratings for non-rated securities).

The fund may also invest up to one-third of its assets directly or indirectly in other securities (including other asset classes), countries, regions, industries or currencies, investment funds, warrants and money market investments, and hold cash (subject to the restrictions provided in the prospectus).

The investment manager assesses the sustainability credentials of

potential investments using a proprietary tool. The fund only invests in assets deemed above a minimum threshold based on the investment manager's rating system.

The fund may use derivatives, long and short, with the aim of achieving investment gains, reducing risk or managing the fund more efficiently.

The fund is valued with reference to the net asset value of the underlying assets.

**Benchmark:** The fund's performance should be assessed against its target benchmark, being to deliver 50% JP CLOIE index + 50% ICE BofA CABS index and compared against 50% Bloomberg Barclays 1-5yr Global Credit index (hedged to USD) and 50% Bloomberg Barclays 1-5yr Global HY Index (hedged to USD). Whilst the fund's investments are generally expected to deviate significantly from the components of the comparator benchmark, dependent on the investment manager's views, the fund's investments may overlap with them. The investment manager invests on a discretionary basis and there are no restrictions on the extent to which the fund's portfolio and performance may deviate from the comparator benchmark. *Dealing Frequency:* You may redeem your investment upon demand. This fund deals daily.

*Distribution Policy:* This share class accumulates income received from the fund's investments, meaning it is kept in the fund and its value is reflected in the price of the share class.



#### Intended retail investor

The fund is intended for retail investors (i) with basic investment knowledge; (ii) who understand the basics of buying and selling shares in stock market listed companies and the way these shares are valued; (iii) who can accept large short-term losses; and (iv) wanting growth over [the longer term] but with easy access to their cash. What are the risks and what could I get in return?

#### **Performance Scenarios**

We have classified this product as 2 out of 7, which is a low risk class.

The fund is in this category because it seeks to provide rewards whilst limiting price volatility.

*Liquidity risk:* In difficult market conditions, the fund may not be able to sell a security for full value or at all. This could affect performance and could cause the fund to defer or suspend redemptions of its shares, meaning investors may not be able to have immediate access to their holdings.

*Credit risk:* A decline in the financial health of an issuer could cause the value of its bonds to fall or become worthless.

## What happens if Schroder Investment Management (Europe) S.A. is unable to pay out?
