What is this product?

Туре	SF Commercial Properties Fund (CHF Distributing) is a real estate funds organized under the laws of Switzerland.
Term	The Fund has no minimum fixed term. Termination of the Fund is only possible in those cases expressly provided for in the "prospectus with integrated fund contract" (fund document).
Objectives	The investment objective of the real estate fund is primarily the long-term preservation of assets and the distribution of adequate returns. The fund mostly invests in commercial properties throughout Switzerland as well as in other investments permitted under the fund contract. The real estate fund owns properties indirectly.

The risk indicator assumes you keep the product for 5 years. The actual risk can vary significantly if you cash in at an early stage and you may get back less.
