

# Key investor information

This document provides you with key investor information about this fund. It is not marketing material. #### Swisscanto (LU) Portfolio Fund Sustainable Protection BT (ISIN: LU0999461139)

Swisscanto (LU) Portfolio Fund Sustainable Protection BT is a unit class of the subfund Swisscanto (LU) Portfolio Fund Sustainable Protection (hereinafter "fund"), a subfund in the umbrella fund Swisscanto (LU). The fund is managed by Swisscanto Asset Management International S.A., Luxembourg.

### Objectives and investment policy

The investment objective is to preserve the capital on a longterm basis and to generate an adequate return through a mixture of investments which are compatible with the Sustainable approach. A hedging strategy by means of derivatives is used in order to avoid significant price declines.

#### Important features:

The fund invests directly or indirectly in fixed or variable-rate securities from around the world as well as other permitted investments. The proportion held in shares and equities is limited to a maximum of 50%. Up to 100% of the investments can be made indirectly (via target funds). The target funds are selected in accordance with the requirements set out in the prospectus. At least 2/3 of the investments are selected by systematically taking into account ESG criteria in sustainability requirements, accordance with which contributes positively to fulfilling the UN SDGs. The fund is classified under Art. 9 SFDR.

The securities are selected on a discretionary basis using a consistent investment process (active management). With regard to portfolio composition, the selection of stocks and the associated weightings are focused on companies from the tailored benchmark index.\* The portfolio composition may deviate considerably from this benchmark index.

The investment policy is to outperform the benchmark index. The Asset Manager may at any time deviate - significantly or insignificantly, positively or negatively - from the benchmark index by actively overweighting or underweighting individual securities and sectors based on market conditions and risk assessments.

Derivatives may be used for achieving the investment objective.

Fund units will be issued or redeemed basically on any bank business day in Luxembourg.

Earnings and profits of the unit class are not distributed, but reinvested.


#### Additional important information:

The total commitments of the fund may not amount to more than 210% as a result of the use of derivatives (max. 100%) and temporary borrowing (max. 10%).

Recommendation on holding period: this fund is appropriate for investors with a medium-term investment horizon (three to five years) or a longer-term investment horizon.


