Objectives and Investment Policy

Templeton Asian Growth Fund (the "Fund") aims to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

equify securities issued by companies of any size traded on stock exchanges in Asian countries (excluding Australia, New Zealand and Japan)
equity securities issued by companies of any size located in, or doing significant business in, Asian countries (excluding Australia, New Zealand and Japan)

The Fund can invest to a lesser extent in:


 equity or debt securities issued by companies of any size located in any country in the Asia region, including any other emerging markets in the Asia region

• equity securities of companies located outside of the Asia Region but which derive a significant proportion of their revenues or profits from the Asia region

The investment team uses in-depth financial analysis to select individual securities that it believes will provide the best opportunities for increased value over the long term.

Terms to Understand

Equity securities: Securities that represent an ownership stake in a company.


Charges
