Objectives and Investment Policy

Templeton Emerging Markets Dynamic Income Fund (the "Fund") aims to increase the value of its investments and to earn income over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:


 equity and equity-related securities issued by companies of any size located in, or doing significant business in, emerging markets · debt securities of any quality (including lower quality debt such as noninvestment grade securities) issued by companies and governments (including government-related corporations) located in emerging markets

The Fund can invest to a lesser extent in:

derivatives for hedging and investment purposes
mortgage- and asset-backed securities
Mainland China through the Bond Connect or directly (less than30% of assets)

The Fund will typically invest at least 25% of its assets in emerging market equity securities and at least 25% of its assets in debt securities but the proportion of the Fund's assets allocated to each strategy may vary over time depending on the investment managers' view of the relative attractiveness of each asset class.

Why is the Fund in this specific category?

The Fund invests mainly in debt and equity securities issued by entities located in emerging countries. Such securities have historically been subject to price movements, generally due to interest rates, market factors or movements in the equity and bond markets. As a result, the performance of the Fund can fluctuate considerably over time.

Risks materially relevant not adequately captured by the indicator:

The Fund may distribute income gross of expenses. Whilst this might allow more income to be distributed, it may also have the effect of reducing capital.

The benchmark of the Fund is the Linked 50% MSCI EM-NR + 50% JPMorgan GBI-EM Global Diversified Index. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

Terms to Understand

Equity securities: Securities that represent an ownership stake in a company.

Chinese Market risk: In addition to typical risks linked to Emerging Markets, investments in China are subject to economic, political, tax and operational risks specific to the Chinese Market. Please also refer to the prospectus for China QFII risk, Bond Connect risk and Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect risk.

Credit risk: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, sub-investment-grade securities.

Derivative Instruments risk: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks.

Emerging markets risk: the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, and that may be impacted by political/economic instability, lack of liquidity or transparency, or safekeeping issues.

Foreign Currency risk: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations.

Liquidity risk: the risk that arises when adverse market conditions affect the ability to sell assets when necessary. Such risk may be triggered by (but not limited to) unexpected events such as environmental disasters or pandemics. Reduced liquidity may have a negative impact on the price of the assets
