### Objectives and Investment Policy

Franklin European Small-Mid Cap Fund (the "Fund") aims to increase the value of its investments over the medium to long term.

The Fund invests mainly in:

- equity and equity-related securities issued by small and mid-sized companies (from €100 million to €8 billion in market capitalisation) located in, or doing significant business in, European countries

The investment team uses in-depth research to create a concentrated portfolio of securities that aims to mitigate risk while generating attractive returns over time. The percentage invested in different industries will change over time, based on which industries seem to be offering the best opportunities.

You may request the sale of your shares on any Luxembourg business day. The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

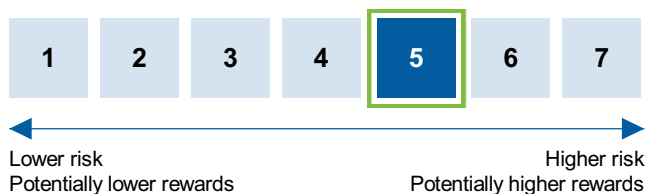

#### Why is the Fund in this specific category?

The Fund invests mainly in equity and equity-related securities of small- and mid-cap companies located in or doing significant business in European countries. As a result, the performance of the Fund can fluctuate considerably over time.

#### Risks materially relevant not adequately captured by the indicator:

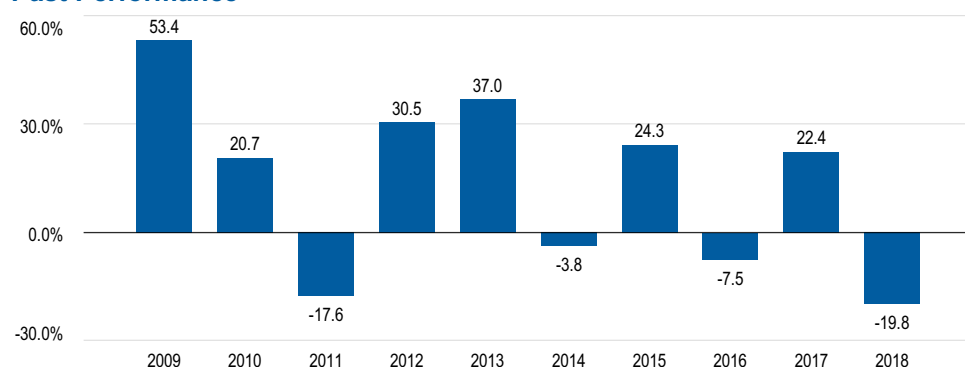
