## **Objectives and Investment Policy**

Templeton Global Income Fund (the "Fund") aims to maximise current income and to increase the value of its investments over the medium to long term.

The Fund pursues an actively managed investment strategy and invests mainly in:

 debt securities of any quality (including lower quality and securities in default) issued by governments, government-related entities and corporations located in any country, including emerging markets
equity securities issued by corporations located in any country

The Fund can invest to a lesser extent in:

Mainland China through the Bond Connect or directly (less than 30% of assets)

 Chinese A-Shares, equity securities of Chinese companies listed in Mainland China (limited to 10% of assets)

units of other mutual funds (limited to 10% of assets)

 debt securities of supranational entities, such as the European Investment Bank

The Fund can use derivatives for hedging, efficient portfolio management and/or investment purposes.

In choosing equity securities, the investment team looks for those that appear to offer attractive dividends as well as the potential for long-term increase in value. In choosing debt securities, the investment team seeks to take advantage of global interest-rate, credit and currency trends to increase long-term value as well as provide income.

The Fund invests mainly in debt and equity securities issued by any government or corporate entity worldwide, including emerging markets. Such securities have historically been subject to price movements, generally due to interest rates or movements in the bond and equity markets. As a result,

#### **Terms to Understand**

**Derivatives:** Financial instruments whose characteristics and value depend on the performance of one or more underlying assets, typically securities, indexes, currencies or interest rates.

**Hedging:** A strategy for totally or partially offsetting particular risks such as those arising from fluctuations in share prices, currencies or interest rates.

Securities in default: Debt securities whose issuer condition has become uncertain and whose issuer is failing to make principal or interest payments when due.

#### Risks materially relevant not adequately captured by the indicator:

**Credit risk:** the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, sub-investment-grade securities.


