### What is this product?

The product is a share of the sub-fund Templeton BRIC Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund. **Objectives** 

### Investment Objective

The Fund aims to increase the value of its investments over the medium to long term.

#### Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

· equity securities issued by companies of any size located in, or doing significant business in, Brazil, Russia, India or China (including Hong Kong and Taiwan)

The Fund can invest to a lesser extent in:

· equity or debt securities issued by companies of any size located in any country, including any other emerging markets.

As one of the pioneers of investing directly in the stock markets of Brazil, Russia, India and China, the investment team uses in-depth financial analysis to select individual securities that it believes will provide the best opportunities for increased value over the long term.

The benchmark of the Fund is the MSCI BRIC Index-NR. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

### **Share Class Policy**

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

#### Processing of subscription and redemption orders

#### Intended retail Investor

The Fund may appeal to investors looking to capital appreciation by obtaining exposure to equity securities issued by companies located in Brazil, Russia, India and China and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.


