What is this product?

Type

The product is a share of the sub-fund Templeton Frontier Markets Fund (the "Fund") which is part of Franklin Templeton Investment Funds, an open-ended investment company with variable capital (SICAV), qualifying as a UCITS.

Term The Fun

The Fund has no maturity date. The Fund could be closed under the conditions laid down in the current prospectus of the Fund.

Objectives

Investment Objective

The Fund aims to increase the value of its investments over the medium to long term.

Investment Policy

The Fund pursues an actively managed investment strategy and invests mainly in:

 equity securities issued by companies of any size located in, or doing significant business in, frontier markets

The Fund can invest to a lesser extent in:

- equity, equity-related or debt securities issued by companies of any size located in any country
- derivatives for hedging and efficient portfolio management

The investment team uses global research expertise with a focus on identifying companies in frontier markets that it believes are overlooked by other investors and offer an opportunity for increased value over the long term

The benchmark of the Fund is the Linked MSCI Frontier Emerging Markets Select Countries Capped Index-NR. The benchmark is used solely as a reference for Investors to compare against the Fund's performance, and the benchmark is neither used as a constraint on how the Fund's portfolio is to be constructed nor set as a target for the Fund's performance to beat. The Fund can deviate from the benchmark.

Share Class Policy

The income received from the Fund's investments is accumulated with the result of increasing the value of the shares.

Processing of subscription and redemption orders

You may request the sale of your shares on any Dealing Day.

Intended retail Investor

The Fund may appeal to investors looking to capital appreciation by obtaining exposure to equity securities issued by companies located in frontier market countries (smaller, less developed and less accessible emerging market countries) and willing to hold their investment over the medium to long term for a minimum period of 3 to 5 years. The Fund is suitable for investors who do not need to have specific knowledge and/or experience of financial markets with the understanding that they may not get back the full amount invested in the Fund.



Risk Indicator





The risk indicator assumes you keep the product for 5 years.
