UBAM is a SICAV managed by UBP Asset Management (Europe) S.A.

Objectives and investment policy

The Fund seeks to grow your capital primarily by investing in equities of companies across the world, including Emerging Markets. It is a concentrated portfolio of equities (usually about 30 positions). The Fund is focused primarily on companies which are expected to provide growth and leading (i.e. sustainably high quality) levels of cash flow return on investment. It is long-term oriented with little need for turnover.

The currency risk between the currencies of the sub-fund's underlyings and the share's currency is mainly hedged.


The Fund invests in stocks of companies that hold leading positions in their particular business fields, deliver steady growth and are attractively valued. However, as an equity fund, its holdings can move in line with or return less than the broad stock market, so investors should be aware that the value of their holdings could fall and that they may not get back their initial investment.

The Fund's value is calculated and expressed in Euros.

Investors in the Fund can redeem their units on any business day in Luxembourg although we recommend a holding period of at least three years.

Any income received by the Fund is reinvested (capitalisation share class).

Risk and reward profile



This indicator represents the annual historical volatility of the Fund over a 5-year period.

Risk category 6 reflects a very high potential gain and/or loss in the portfolio's value.

This is due to investments in equities deemed undervalued on worldwide markets.

Significant risk(s) for the Fund not taken into account in this indicator include the following:

Liquidity risk: Liquidity risk exists when particular investments are difficult to purchase or sell. This can reduce the Fund's returns because the Fund may be unable to transact at advantageous times or prices.

Currency risk: The Fund invests in overseas markets. It can be affected by changes in exchange rates which may cause the value of your investment to decrease or increase.

Counterparty risk: As the Fund uses over-the-counter derivatives, there is a risk that the counterparty to the transactions will wholly or partially fail to honour its contractual obligations. This may result in a financial loss to the Fund.

Charges


