## What is this product?

### Type

UBS (Lux) Equity SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

### Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

### Objectives

The investment fund is a feeder fund which has the same investment objective as the master fund, namely to generate ongoing long-term capital appreciation. The feeder fund invests at least 85% of its net assets in the share class 'U-B-PF-acc' of the Master Fund UBS (Irl) Investor Selection – O'Connor China Long/Short Alpha Strategies UCITS Fund. At the level of the master fund, the fees, costs and expenses relating to the investment in the share class are an annual investment manager fee of up to 0.30%, and a performance fee of up to 20%. The remaining 15% may be invested in liquid assets.

The master fund invests primarily in equities, equity derivatives and equity index derivatives listed primarily on exchanges in China, Hong Kong, Taiwan and the US. The fund uses a combination of equity hedge and relative value strategies. Equity hedge strategies invest in publicly traded equities. They use fundamental analysis to generate alpha through excellent stock selection. The portfolio construction is primarily based on fundamental bottom-up analyses in combination with top-down macro analysis. Relative value comprises non-directional strategies that use arbitrage to exploit valuation discrepancies and other opportunities between different stocks in the same sector or listed on exchanges in different countries.

The investment fund is actively managed without reference to a benchmark.

Sustainability risks are not systematically integrated due to the investment strategy and the nature of the underlying investments.

The return of the fund depends primarily on equity market development and dividend payments.

The income from this share class is reinvested (reinvestment).

### Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy medium term investment needs. The fund is suited to be acquired by the target client segments without any restriction of the distribution channel or platform.

## What are the costs?
