What is this product?

Type

UBS (Lux) Bond SICAV is an undertaking for collective investment in transferable securities (UCITS) with the legal status of an open-ended investment company (SICAV) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

Objectives

The actively managed sub-fund invests predominantly in short-term corporate bonds issued by borrowers with high credit ratings (classified as investment grade by the main rating agencies), with an average duration of 1 to 3 years. This sub-fund promotes environmental and/or social characteristics but does not pursue a sustainable investment objective.

The sub-fund uses the benchmark Bloomberg Euro Corporate Index 500mio+ 1-3yrs EUR as a reference for portfolio construction, performance assessment, sustainability profile comparison and risk management purposes. Although a portion of the portfolio may be invested in the same instruments and at the same weightings as the benchmark, the Portfolio Manager is not bound by the benchmark when selecting instruments. In particular, the Portfolio Manager may, at its discretion, invest in bonds of issuers not included in the benchmark and/ or structure the proportion of investments in sectors differently from their weighting in the benchmark in order to take advantage of investment opportuinities. In times of high market volatility, the sub-fund's performance may therefore deviate significantly from the benchmark.

The sub-fund manager combines various, carefully selected debtors and securities with different maturities with the objective of taking advantage of interesting return opportunities while controlling risk.

The return of the fund depends primarily on the development of interest rates and creditworthiness of the issuers and the interest income. The return may also be affected by currency fluctuations, where active or unhedged positions exist. The income from this share class is reinvested (reinvestment).

Intended retail investor

This fund applies to retail investors with a basic financial understanding, who can accept a possible loss on the investment amount. The fund is aimed at generating a substantial part of its yield through recurring income and addresses a preference for Sustainable Investing, while granting daily access to the capital under normal market conditions. With their investment in this fund, investors can satisfy short term investment needs. The fund is only suited to be acquired within a discretionary mandate.

What are the costs?
