What is this product?

Type

UBS (Lux) Equity Fund is an undertaking for collective investment in transferable securities (UCITS) with the legal status of a Fonds Commun de Placement (FCP) established under Part I of the Luxembourg Law of 2010 relating to undertakings for collective investment.

Term

The Product does not have a maturity date (the Product has been established for an indefinite period of time). The Manufacturer may terminate the Product early. The amount you will receive upon early termination may be less than the amount you invested.

Obiectives

The actively managed investment fund invests worldwide primarily in the shares of companies related to the biotechnology sector. Based on sound analysis by our investment specialists worldwide, the fund manager combines carefully selected equities of various companies from different countries and segments in this sector with the aim of taking advantage of interesting return opportunities while keeping risks under control.

The portfolio manager has discretion to construct the portfolio and is not bound by the benchmark in terms of equities and weighting. The investment fund is actively managed in relation to the benchmark MSCI US Investable Market Biotechnology 10/40 (net div. reinvested).

The benchmark is used for portfolio composition, performance comparison and risk management.

This sub-fund promotes environmental and/or social features but does not pursue a sustainable investment objective.

The fund's return is primarily dependent on equity market performance, currency fluctuations and dividend distributions.

The income from this share class is reinvested (reinvestment).

Intended retail investor

The fund is aimed at growing the investment value, while granting daily access to the capital under normal market conditions. What are the costs?
