What is this product?

Type

The fund is a contractual umbrella fund under Swiss law of the type "Other funds for traditional investments" pursuant to the Swiss Federal Act on Collective Investment Schemes (CISA) of June 23, 2006 with several subfunds.

Objective

The subfund's investment policy is to achieve long-term capital growth.

The subfund mostly invests in equities and equity-like securities of companies represented in the Vescore Switzerland universe.

The strategy of this subfund follows a systematic indexing approach and is based on the Vescore Switzerland universe, which is composed of the 50 largest companies listed on the SIX Swiss Exchange and is rebalanced on a quarterly basis. The securities are weighted to ensure that the portfolio is primarily focused on the systematic factors of value, quality, momentum, size and risk. These are the systematic factors which explain a large part of equity market returns.

Derivatives can be used for hedging purposes and for efficient portfolio management. This does not produce a leverage effect.

Shares in the subfund can be redeemed on any working day, with the exception of public holidays in Switzerland or when a significant part of the stock exchanges and markets of the subfund is closed.

Income can be distributed each year.

AN shares do not grant any discounts or retrocessions. They are exclusively reserved for certain distribution companies at the sole discretion of the management company.

Taking into consideration the minimum recommended holding period, the return will depend on the performance of the underlying investments.

The custodian bank of the fund is CACEIS Investor Services Bank S.A., Esch-sur-Alzette, Zurich branch.

Intended Retail Investor

The sub-fund is intended for retail investors with knowledge and/or experience of these types of products, that have obtained appropriate investment advice, that have long-term investment horizon and that have the ability to bear losses up to the amount they have invested in the sub-fund.

Term

This product has no expiration date. The subfund was established for an indefinite period of time. The fund management company is unilaterally entitled to liquidate the product at any time. The amount received by the investor in the event of early termination may be less than the amount invested.

What are the risks and what could I get in return?

The summary risk indicator (the "SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

This rates the potential losses from future performance at a medium level, and poor market conditions could impact our capacity to pay you.

Be aware of currency risk. In some circumstances, you may receive payments in a different currency, so the final return you will get may depend on the exchange rate between the two currencies. This risk is not considered in the SRI.

What happens if Vontobel Fonds Services AG is unable to pay out?

The investor may not face a financial loss due to the default of the Product Manufacturer.

The assets of the Fund are held in safekeeping by its Custodian Bank, CACEIS Investor Services Bank S.A. (the "Custodian"). In the event of the insolvency of the Product Manufacturer, the Fund's assets in the safekeeping of the Custodian will not be affected. However, in the event of the Custodian's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. This risk is mitigated to a certain extent by the fact that the Custodian is required by law and regulation to segregate its own assets from the assets of the Fund. The Custodian will also be liable to the Fund for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfill its obligations (subject to certain limitations as set out in the agreement with the Custodian).

What are the costs?

Cost over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

Recommended holding period: 6 years

Due to the investment policy and the risk profile of the subfund, a holding period of 6 years is recommended. Investors can sell the investment at any time at no additional cost regardless of the recommended holding period. Units may be sold on a daily basis (on bank working days). The exit costs are shown above.
