## What is this product?

#### Type

The Fund was incorporated as a société anonyme, an open-ended fund formed under the amended law of 17 December 2010 on undertakings for collective investment. It is an umbrella fund with multiple compartments, the Sub-Fund being one of these compartments. The Shares are class of shares in the Sub-Fund.

#### Objective

This actively managed Sub-Fund aims to achieve attractive investment returns by investing in Green Bonds. It has a sustainable investment objective within the meaning of Article 9 SFDR, which consists in investing in debt instruments issued for projects and/or by issuers that contribute to pre-defined so called "Impact Pillars", with an environmental focus. More details can be found in the prospectus. While respecting the principle of risk diversification, the Sub-Fund invests worldwide at least 80% of its net assets in various fixed-income instruments classified as "Green Bonds" according to international standards such as the Green Bond Principles of the International Capital Market Association (ICMA), including asset-backed and mortgage-backed securities ("ABS/MBS"), convertible and warrant bonds issued by public and/or private borrowers worldwide, including emerging markets. The investments shall be made in a broad range of rating categories, including the high yield sector including the high yield sector.

Including the high yield sector. Type of approach: The Sub-Fund invests in Green Bonds, instruments where the proceeds will be applied to finance or refinance new and/or existing projects that are beneficial to the goals of climate change mitigation and protection of the environment (e.g. solar power, energy efficiency of industrial processes or promoting public transport). It also invests in sustainable and/or social bonds based on standards of the Sustainability Bond Guidelines or the Social Bond Principles. In addition, it may invest in issuers that have sustainable investments as objectives such as energy efficiency, environmental protection, access to health care, through their products, services or technologies. **Threshold**: At least 100% of the securities in the Sub-Fund have the sustainability selection criteria applied to it. All investments qualifying as sustainable investments are screened against all significant harm indicators relevant to the economic sector. **Main methodological limits**: potential inconsistency, inaccuracy or lack of availability of ESG data issued by third party providers. Up to 20% of the Sub-Fund's new sector is invested outside the aforementioned Green Bond universe. In total it may invest up to 10% in

Up to 20% of the Sub-Fund's net assets may be invested outside the aforementioned Green Bond universe. In total it may invest up to 10% in asset-backed and mortgage-backed securities ("ABS/MBS"), 15% in high yield securities, 20% in convertible and warrant bonds issued by public and/or private borrowers and 20% in money market instruments and bank deposits. It may also hold up to 20% of its net assets in bank deposits at sight.

The Sub-Fund may use derivatives to achieve the investment objective and for hedging purposes.

The currency of this class is NOT hedged against the Sub-Funds's main currency. The investor consequently bears the full currency risk. Redemption of shares: daily when banks in Luxembourg are open for normal business (see prospectus for details and exceptions).

This share class of the sub-fund carries out a steady monthly distribution.

The Sub-Fund is not managed with reference to a benchmark. The portfolio manager has full investment discretion within the predefined investment limits.

Taking into consideration the minimum recommended holding period, the return will depend on the performance of the underlying investments. The Fund's depositary is CACEIS Investor Services Bank S.A.

This Sub-Fund is part of an umberlla fund. The various sub-funds are not liable for one another, i.e. only the gains and losses of this Sub-Fund are relevant for you as an investor. You can request the conversion of some or all of your Shares in the Sub-Fund in accordance with the "Conversion of Shares" section, unless stipulated otherwise in the special part of the sales prospectus. The Sub-Fund is intended for retail investors with knowledge and/or experience of these types of products, that have obtained appropriate investment advice, that have medium-term investment horizon and that have the ability to be rlosses up to the amount they have invested in the Sub-Fund.

#### Term

The Shares do not have a maturity date. The Product Manufacturer can terminate the Shares unilaterally. The Shares, the Sub-Fund and the Fund can be terminated early and liquidated in the cases set out in the prospectus and the articles of incorporation of the Fund.

## What are the risks and what could I get in return?

The summary risk indicator (the "SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.



The risk indicator assumes you keep the product for 3 years. We have classified this product as 3 out of 7, which is a medium-low risk class. This rates the potential losses from future performance at a mediumlow level, and poor market conditions are unlikely to impact our capacity to pay you.

# What happens if Vontobel Asset Management S.A. is unable to pay out?

Average return each year

The investor may not face a financial loss due to the default of the Product Manufacturer.

The assets of the Fund are held in safekeeping by its depositary, CACEIS Investor Services Bank S.A. (the "Depositary"). In the event of the insolvency of the Product Manufacturer, the Fund's assets in the safekeeping of the Depositary will not be affected. ## Recommended holding period: 3 years

Based on the investment policy and the risk profile of the Sub-Fund, a holding period of 3 years is recommended. Investors can sell the investment at any time, irrespective of the recommended holding period, without additional cost. Shares can be sold daily (on business days). Exit costs are presented above.
