What is this product?

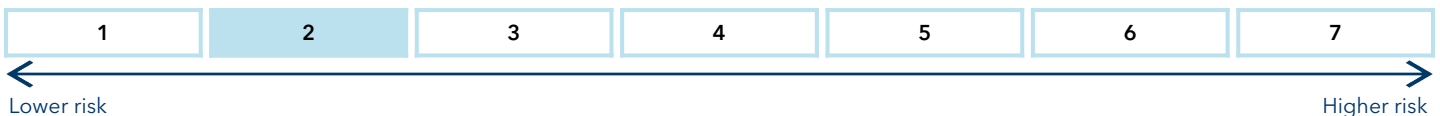

Objectives: The sub-funds aim for returns better than the average short-term money-market interest rates, whilst paying particular attention to security, stability, diversification and liquidity. The sub-funds therefore invest in money-market deposits and accounts and short-maturity, liquid government and corporate bonds rated at least BBB- by Standard & Poor's or which have an equivalent credit rating. The sub-funds are broadly diversified in terms of issuers, sectors and countries. Each position is valued daily at market prices (mark to market). Investments in foreign currencies are generally hedged against the sub-fund currency in order to avoid currency risks.

Intended retail investor: In the member state of origin, the product is intended for professional and private investors with a medium-term investment horizon, basic experience and who are able to bear a limited financial loss. The product may be used for capital appreciation.

What are the risks and what could I get in return?

Risk Indicator:



The risk indicator assumes you keep the product until 4 years.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the fund are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Performance-Scenarios:

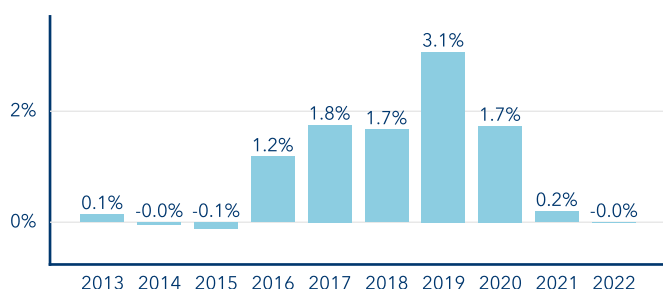
Recommended holding period: 4 years
