Objectives and Investment Policy

The Fund aims to achieve growth on your investment by investing in a focussed list of shares in companies worldwide.

The Fund will invest at least two thirds of its assets (excluding cash) in ordinary shares and preferred shares. A preferred share typically pays dividends at a specified rate and has preference over ordinary shares in dividends and the liquidation of assets.

The Fund may invest up to one third of its assets (excluding cash) in bonds convertible into shares and in other interest-bearing securities. Such bonds may be issued by governments, international bodies or companies rated, or deemed to be of, investment grade or better. A rating agency gives an investment grade rating when it believes that there is a relatively low risk that the issuer of a bond will be unable to make payments.


The Fund may invest up to 10% of its assets in other funds, of which up to 5% of its assets may be invested in funds investing in equity markets globally.

The Fund may invest no more than 20% of its assets in companies in emerging market countries.

At times, the Fund may also invest in cash and cash-like instruments.

The Fund may use instruments whose value is determined by changes in the value of the underlying assets they represent (derivatives). The Fund may do so in order to manage the Fund more efficiently (e.g., reducing risks or costs or generating additional growth or income).

Risk and Reward Profile



The risk category is based on historical data and may not be a reliable indicator of the future risk profile of the Fund. The risk category shown is not guaranteed and may change over time.

The numerical scale is complex. For example, 2 is not twice as risky as 1. The gap between 1 and 2 might not be the same as the gap between 5 and 6. A category 1 fund is not a risk-free investment – the risk of losing your money may be small, but the chance of making gains is also limited.

The Fund is in its risk category as shown above as it typically produces higher rewards than other funds (such as money market funds) and is higher risk as a result of investing in the shares of companies worldwide.

Risks materially relevant to the Fund which may not be adequately captured by the indicator:

- **Investment risk:** the Fund may not achieve its investment objective and the value of shares in the Fund may fall.
- **Currency risk:** the Fund invests in assets which are priced in currencies other than the Fund's base currency (British Pounds). Changes in exchange
