What is this product?**Type**

The Product is a share of the Sub-fund Wellington Euro High Yield Bond Fund (the "Fund") which is part of the Wellington Management Funds (Ireland) plc (the "Umbrella Fund"), an open-ended investment company with variable capital and segregated liability between Funds incorporated with registered number 267944 and is authorised in Ireland as a UCITS pursuant to the Regulations.

Term

The Umbrella Fund and the Fund do not have a fixed term or maturity period, but the Management Company, with the approval of the Depositary, is entitled to give notice of the Umbrella Fund's dissolution at any time. In the event that the Management Company considers that changes in the political, economic, military, regulatory or business environments, or reductions in the scale of a Fund's total net assets compromise the effective management of a Fund, then the Management Company is empowered to liquidate the Fund at any time.

Objectives

The Fund seeks long-term total returns (income and capital appreciation).

The Fund will be actively managed against the ICE BofA Euro High Yield Constrained Index ("the Index"). The Index tracks the performance of Euro-denominated bonds, below investment grade corporate debt publicly issued by corporations from across the world. Below investment grade securities are those which are deemed to have relatively low credit rating. The largest issuers are capped at 3% of the weight of the total index, with the excess weight redistributed equally amongst the issuers under that cap. Whilst the Fund is managed relative to the Index its holdings may deviate from the Index from time to time.

The Fund seeks to achieve its objective by primarily investing in below investment grade (credit rating of below Baa3 by Moody's, BBB- by Standard & Poor's, or BBB- by Fitch) debt securities denominated in European currencies issued worldwide. The majority of the Fund's debt securities will be denominated in Euro. Any non-Euro currency exposures will generally be hedged to Euro.

The Investment Manager looks to construct a portfolio that is well-diversified by industry but also able to take advantage of favourable secular or cyclical industry trends. Analysis will also include a geographical view, which will identify the regions they wish to invest large or small amounts in. The Fund is subject to a strong focus on risk, which is actively managed at the security, sector and total

portfolio level; with the objective of generating strong risk-adjusted returns in a wide variety of market environments.

The Fund will invest, either directly or via derivatives, in bonds issued by government, supranational or corporate bond issuers. The average credit quality of the Fund's holdings will tend to be in the B2 (Moody's)/B(S&P and Fitch) range but is expected to fluctuate. Derivatives will be used to hedge (manage) risk and/or volatility and for investment purposes (such as gaining exposure to a security). Derivatives will form a significant part of the strategy and will impact performance.

The Index may be considered during portfolio construction and is used for performance comparison purposes. Fund securities may be components of the Index but are not expected to have similar weightings. The Investment Manager may limit the extent that industry, currency and issuer weightings, as well as overall interest rate duration, differ from the Index but this should not be expected to limit the Fund's ability to achieve long-term total returns in excess of the Index.

The Fund will seek to support certain social characteristics by maintaining an overall weighted average social (S) score in excess of the Index, using an internal rating scale of 1-5, where 1 is the best rating.

Income policy

Any income allocated to the Share class from the Fund is reinvested.

Dealing Frequency

Shares can be bought or sold daily in accordance with the Prospectus.

Intended retail Investor

The Fund is intended for basic retail investors with a long-term investment horizon seeking capital appreciation and who are able to bear capital loss. Investors in the Fund should be prepared to accept, in normal market conditions, a high degree of volatility of net asset value from time to time. The Fund is suitable as an investment in a well-diversified portfolio. An investment in the Fund should not constitute a substantial proportion of an investment portfolio and may not be appropriate for all investors.

Performance Scenarios

What happens if Wellington Luxembourg S.à r.l. is unable to pay out?

The assets of the Fund are held in safekeeping by its depositary. In the event of the insolvency of the Management Company, the Fund's assets in the safekeeping of the Depositary will not be affected. However, in the event of the Depositary's insolvency, or someone acting on its behalf, the Fund may suffer a financial loss. However, this risk is mitigated to a certain extent by the fact the Depositary is required by law and regulation to segregate its own assets from the assets of the Fund. The Depositary will also be liable to the Fund and the investors for any loss arising from, among other things, its negligence, fraud or intentional failure properly to fulfil its obligations (subject to certain limitations).

There is no compensation or guarantee scheme protecting you from a default of the Fund's depositary.

What are the costs?

Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the 5 year holding period we have assumed the product performs as shown in the moderate scenario

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

This product has no required minimum holding period but is designed for long-term investment; you should have an investment horizon of at least 5 years.

The Management Company shall redeem shares of this Fund at the redemption price on each dealing day. Redemptions of the applicable Fund will be effected at the valuation point on the relevant dealing day. The price is based on the net asset value per share of each class determined at the valuation point. Redemption requests received after the dealing deadline will be treated as having been received by the following dealing deadline unless otherwise determined by the Management Company.
