What is the product?

Type: This Product is an investment company qualifying as UCITS Sub-fund in accordance with the UCITS law.

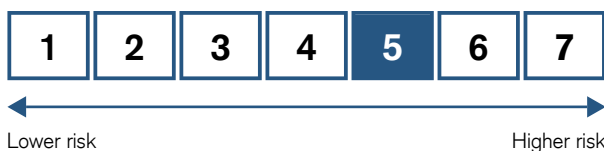
Term: This Product has no maturity date. The Sub-fund has been established for an indefinite period of time. The Board of Directors of the Investment Company is entitled to liquidate, merge or reposition the Product at any time unilaterally in case the Product can no longer be managed in the interest of the investors. The amount the investor will receive upon early termination may be less than the amount invested.

Objectives: The Sub-fund is actively managed and refers to the MSCI ACWI Net Total Return Index (the "Benchmark") for the purpose of the performance fee calculation. The Sub-fund has a sustainable investment objective (within the meaning of Article 9 of Regulation (EU) 2019/2088). Details are available in the prospectus and the ESG website disclosure of the Sub-fund. As part of the investment process, the Sub-fund's Investment Manager has full discretion over the composition of the Sub-fund's portfolio and may take exposure to companies, countries or sectors not included in and/or that have different weightings than the Benchmark. The Sub-fund's Investment Manager may set discretionary internal risk thresholds which may reference deviations from the Benchmark. While it is expected that the Sub-fund's deviation from the Benchmark will be significant, there are no restrictions on the extent to which the Sub-fund's performance may deviate from the one of the Benchmark. The Sub-fund invests at least 2/3 of its net assets in equities and equity-type securities of companies worldwide that achieve at least 50% of their revenues with exposure to global secular trends (e.g., demographics, climate change, technology disruption). Up to 1/3 of the Sub-fund's net assets can be invested in fixed- and floating rate securities, convertibles, cum-warrant bonds and money market instruments rated at least BBB-. The Sub-fund is not limited to a certain currency or geographical scope, although investments in emerging markets will not exceed 35% of its net assets. In order to reach its objective, the Sub-fund can use derivative instruments such as options and futures to protect against movements in currencies and security prices and for efficient portfolio management. The investor can buy or sell shares on a daily basis (Luxembourg bank business day). This Share class does not make regular distributions. The Sub-fund shall bear the costs of standard charges incurred by the Sub-fund through securities transactions in relation to the portfolio.

Intended Retail Investor: This Product is intended for retail investors with sufficient knowledge and experience in collective investment schemes and similar products, an ability to bear an average investment loss, and a long-term investment horizon.

What are the risks and what could I get in return?

(A) Summary Risk Indicator



The risk indicator assumes you keep the Product for 7 years. The actual risk can vary significantly if you redeem at an early stage and you may get back less.

The Summary Risk Indicator is a guide to the level of risk of this Product compared to other products. It shows how likely it is that the Product will lose money because of movements in the markets. We have classified this Product as 5 out of 7, which is a medium-high risk class and poor market conditions will likely impact our capacity to pay you. **Be aware of currency risk** if your reference currency differs from the currency of the Product. You may receive payments in a different currency, so the final return you will get depends on the exchange rate between the two currencies.
