What is this product?

Type

Jersey law governed, uncertificated, registered, collateralised debt security.

Objectives

WisdomTree Petroleum is a fully collateralised, UCITS eligible Exchange Traded Commodity (ETC) designed to provide investors with a total return exposure to a basket of Petroleum futures contracts. The ETC aims to replicate the Bloomberg Commodity Petroleum Subindex 4W Total Return Index (BCOMPE4T) by tracking the Bloomberg Petroleum Sub Excess Return Index and providing the interest revenue adjusted to reflect fees and costs associated with the product. For example, if the Bloomberg Commodity Petroleum Subindex 4W Total Return Index rises by 1% over a day, then the ETC will rise by 1%, excluding fees. However if the Bloomberg Commodity Petroleum Subindex 4W Total Return Index falls by 1% over a day, then the ETC will fall by 1%, excluding fees.

You may trade this product on various stock exchanges at your own discretion. Price changes in the futures contracts referenced in the Benchmark will not necessarily result in correlated changes in the level of the Benchmark or of the Product. This may be due to a number of factors including the effect of "rolling" of futures contracts.

The unfavourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Petroleum between 29/05/2017 and 21/04/2020. The moderate scenario for where you exit after the recommended holding period occurred to the WisdomTree Petroleum between 28/11/2018 and 21/10/2021. The favourable scenario for where you exit after the recommended holding period occurred to the WisdomTree Petroleum between 28/04/2020 and 22/03/2023. What happens if WisdomTree Commodity Securities Limited is unable to pay out?
